WHEN THE FOLLOWING PROCEEDINGS WERE HAD, THAT IS:

Judge Powers called the meeting to order and gave the invocation. Commissioner Carter led the Court in the Pledge of Allegiance to the Flags.

PRESENTATION OF RETIREMENT PLAQUE TO MS. HERMINIA G. TAMAYO

Maintenance Supervisor Ron Knott presented a retirement plaque to Herminia "Minnie" G. Tamayo. The plaque reads: Hays County Commissioners' Court – Mrs. Herminia G. Tamayo – At retirement and in recognition of your faithful and dedicated service to the Building Maintenance Department. Mrs. Tamayo's loyalty and sustained performance of duty is greatly appreciated by fellow employees and the citizens of Hays County - 1986-2003.

PRESENTATION BY STEVEN MUSICK OF THE TEXAS COMMISSION OF ENVIRONMENTAL QUALITY REGARDING PRIORITY GROUNDWATER MANAGEMENT AREAS (PGMAS) AND SUSTAINABLE WATER SUPPLIES [T1-52]

Steve Musick (Water Quality Planning & Assessment Section - Texas Commission on Environmental Quality) advised that Commissioner Carter asked him to give the court an update on groundwater management issues. He stated that the aquifer of concern is the Trinity Aquifer which has a critical ground water problem (a designated "priority groundwater management area"). The aquifer is tight and the movement of the groundwater is very slow and yield to wells is limited. Future demands are significant and it is clear that groundwater management is needed in this area. He spoke of Legislature's policy that groundwater be managed at the local level - they point to groundwater conservation districts as the primary mode of managing groundwater at the They have also given authority to counties to look at groundwater availability issues in their area and look at it through the land development platting process (Water Code and Local Government Code). He spoke of Water Code Chapter 35 and Local Government Code (LGC) Chapter 230 that addresses water availability. Environmental Health Director Allen Walther advised that we used the water availability statutes when developing our rules. Mr. Musick provided a map of the "Hill Country Priority Groundwater Management Area (PGMA). He spoke of SB2 regarding management plans - requiring joint planning by groundwater districts. Chapter 230 LGC enables the county to establish guidelines and get very good information from developers in the platting process that would identify the amount of water needed by the land-use being contemplated and provide information of effects on the water table and how much water levels might decline and how much is available to meet the needs. The statute is aimed at domestic wells rather than public supply system at the county level. In response to questions from Commissioner Carter, Steve Musick spoke of changes that added hydro-geologist, along with engineer, to address future water availability (20 years). Allen Walther advised that our rules are more expansive than LGC Chapter 230 - water quality and water quantity are also considered we require in their report that they demonstrate that they have capacity to serve that subdivision at full build-out - the reports go well beyond any short term - we also require that they identify impact on adjacent wells. No one can guarantee that water will be there forever - no district could provide a letter guaranteeing a 100-150 year water supply. Allen Walther advised that they are required to look at the capacity of the aquifer and feels like our rules are comprehensive. Steve Musick spoke of Water Code Chapter 35 being meant for Priority Groundwater Management Areas (PGMA) and to provide more flexibility and authority for the county to do more and Chapter 230 provides a more routine process to facilitate counties that don't have the staff to do a more detailed evaluation.

20798 AUTHORIZE THE COUNTY JUDGE TO SIGN AND EXECUTE THE JOINT POWERS AGREEMENT WITH CAPITAL AREA METROPOLITAN PLANNING ORGANIZATION (CAMPO) [T1-562]

Maureen Daniels (Assistant Director of CAMPO) spoke of minimal changes in the joint powers agreement – it increases the voting membership by one (1) and changes the name of the organization from Austin Transportation System (ATS) to Capital Area Metropolitan Planning Organization (CAMPO). A motion was made by Commissioner Burnett, seconded by Commissioner Molenaar to authorize the County Judge to sign and execute the Joint Powers Agreement with the Capital Area Metropolitan Planning Organization (CAMPO) and forward it to the Executive Director. All voting "Aye".

PRESENTATION BY COMMISSIONER RUSS MOLENAAR REGARDING REGIONAL PLANNING ISSUES INCLUDING, BUT NOT LIMITED TO TOPICS SUCH AS PLANNING FOR OPEN SPACES, DEVELOPMENT STRATEGIES, INFRASTRUCTURE NEEDS, WATER QUALITY AND SUPPLY, DEVELOPMENT AGREEMENTS, AND ROADWAY PLANNING (SPECIFIC COMMENTS RELATING TO THE POTENTIAL DEVELOPMENT AROUND STATE HIGHWAY 45 AND RM 967 INCLUDED) [T1-706]

Commissioner Russ Molenaar advised that this is not a 2020 Plan - it is a vision he had when visiting with a developer regarding potential development around State Highway 45 and RM967. This proposed development borders the Proposition 2 land and lies over the aquifer. He spoke of greenbelts and park roads and he spoke of creating a wildlife preserve with natural vegetation. The City of Austin wants to create a hike and bike trail. He spoke of cluster development in order to come up with greenbelts. He spoke of working with TNRCC, Edwards Aquifer Authority, etc. to create a regional plan to prevent future problems (protect the aquifer) - development is going to happen – he supports development agreements and urged everyone to work together (no criticizing and no lawsuits). Developers would be a part of regional planning and would give greenbelts. Commissioner Molenaar spoke of "no growth policy" mentality and protecting property owners rights. He spoke of water availability - surface water and public wastewater systems fall under TNRCC and not local authority. Jim Green urged the court to be careful regarding parkland dedication - may be a federal violation of "taking of property without just compensation".

Environmental Health Director Allen Walther spoke of Senate Bill 873 which gave authority to certain counties addressing rapidly urbanizing areas – it allows counties to address rules concerning development related to protecting the health safety and welfare of our citizens – it has a very broad definition. They gave counties the ability to adopt rules consistent with the rules of cities. We are growing and will continue to grow and their focus has been to try and identify areas that need protection .

Allen Walther spoke of being unable to control density except through the on-site sewage system regulations. He spoke of offering incentives to encourage developers to do things that are not required by law. He spoke of identifying stakeholders and meeting with them. They will need technical and legal expertise to develop draft rules, public hearings will be held, and they will need to get someone to conduct the necessary legal reviews. Commissioner Molenaar advised that they are open to input from anyone.

The court convened into closed Executive Session pursuant to Section 551.074 of the Texas Government Code, relating to possible revisions to the title, job duties and compensation for the position presently identified as the Director of Environmental Health. Upon completion of the closed session, the court reconvened into open meeting and the following action was taken. [T1-2045] A motion was made by Commissioner Molenaar, seconded by Commissioner Burnett to accept organizational chart with Allen Walther as County Administrator and accept that job description at a salary of \$90,000 per year effective February 1, 2003 with additional funding required to come out of contingency funds. Commissioner Ingalsbe felt like more discussion is needed and she would like to postpone action for another week. Commissioner Carter felt like it is not right to put a person over other department heads who does not have greater credentials than that department head and she felt like you should put the County Engineer over Environmental Health. Jim Green (Public Comment) advised that he protests this action - we do not need a county manager because we have elected officials to do that job. He feels like department heads should report to the court and not to a county manager. Pat Moore (Public Comment) concurred with Jim Green and opposes creating this position and increase the salary - we have five elected people to oversee our county and she would like to see it continue "as is". Jackie Craig (Public Comment) does not feel like we need this position and she urged the court to not do this. Commissioner Carter spoke in opposition to this action. Commissioner Molenaar, Commissioner Burnett, and Judge Powers voting "Aye". Commissioner Ingalsbe and Commissioner Carter voting "No".

County Administrator Of Programs and Planning

Summary:

Under general supervision of the Hays County Commissioners Court directs all departments not under the appointment and direct supervision of other elected officials.

Tacke

Provides management supervision of all assigned department heads. Additional tasks related to assigned departments include program development & oversight, department head performance evaluations, budgetary review, and time.

With direction from Commissioners Court, prepares and directs policy and planning relating to inter-jurisdictional agreements and partnerships including, but not limited to, regional planning, environmental protection, infrastructure development, and county subdivision and development regulations. Reviews and negotiates related contracts.

Develops, recommends, and implements policies and procedures to advance Hays County's missions, goals, and objectives. Handles and oversees the resolution of inter-departmental issues. Provides informational programs and workshops to the commissioners court and public on county activities.

Serves as primary liaison between Hays County Commissioners' Court and other elected officials.

Supervisory Responsibilities

Hires, evaluates, promotes, disciplines, and terminates employees following procedures and policy as may be directed by the commissioners court. Assigns work to employees and department heads and monitors their progress. Guides and develops employees in the accomplishment of their duties and professional growth.

The Court convened into closed Executive Session pursuant to Section 551.072, Texas Government Code, relating to possible real estate purchases consistent with the Hays County parks and Open Space Master Plan including but not limited to submission of a Grant Application to the Texas Department of Parks & Wildlife for partial funding. Upon completion of the closed session, the court reconvened into open meeting. [T1-2220] Commissioner Molenaar advised that there is no action to be taken.
