HOLD A PUBLIC HEARING ON A PROPOSAL TO INCREASE TOTAL TAX REVENUES FROM PROPERTIES ON THE TAX ROLL IN THE PRECEDING TAX YEAR BY 3.51 PERCENT

Judge Sumter declared the public hearing open. Sherri Bilson, Peggy Jones, and Clint Frankmann spoke in opposition to a tax increase. Judge Sumter closed the public hearing.

The County Judge announced that the date to vote on the tax rate and the budget is Sept. 16, 2009 at 9:00 a.m.

Proposed tax rate = **\$0.4692** per \$100 of taxable value Current tax rate = **\$0.4550** per \$100 of taxable value

Commissioner Conley suggested various cuts in the budget to bring the tax rate down. Commissioner Barton spoke of emergency services and 9-1-1 dispatch. Court discussed cutting the budget.

APPROVE GRIEVANCE COMMITTEE SELECTION PURSUANT TO LOCAL GOVERNMENT CODE 152.015

Judge Sumter suggested trying to get nine citizens from the selections previously made and made today or go to the option of creating the Grievance Committee consisting of six elected officials and three citizens pursuant to statute.
