31366 APPROVE PAYMENTS OF COUNTY INVOICES

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Whisenant to approve payments of County Invoices in the amount of \$440,529.48 as submitted by the County Auditor. All present voting "Aye". MOTION PASSED

31368 APPROVE SPECIFICATIONS FOR IFB-B03, DEMOLITION OF BUILDINGS ON CIVIC CENTER LOOP, AND AUTHORIZE PURCHASING TO SOLICIT FOR BID AND ADVERTISE

31369 APPROVE RETIREE BENEFITS REVIEW COMMITTEE RECOMMENDATION TO REVISE SECTION 5:05 OF THE HAYS COUNTY PERSONNEL POLICY

Approve Retiree Benefits Review Committee recommendation to Revise section 5:05, Retiree Insurance section. From: "For the retiree to qualify for partial county funding of medical benefits, the retiree must have at least 15 years continuous service with Hays County, and must be receiving Hays County funded insurance at the time of retirement with no break in service or insurance coverage." To: For the retiree to qualify for partial county funding of medical benefits, the retiree must have at least 15 years continuous service with Hays County, and must be receiving Hays County funded insurance at the time of retirement with no break in service and with insurance coverage for at least 75% of the time during their service with Hays County. **A motion was made by Commissioner Ingalsbe, seconded by Commissioner Whisenant to approve Retiree Benefits Review Committee recommendation to revise section 5:05 of the Hays County Personnel Policy. 31370 APPROVE OUT OF STATE TRAVEL FOR CORPORAL KEN CARPENTER TO ATTEND THE COPTECH FORUM IN CHARLOTTE, NC

Out of state travel is needed to send Corporal Ken Carpenter to the COPTECH forum Charlotte, NC on April 3-5, 2016. Corporal Carpenter is in charge of Technology for the Sheriff's Office and this forum will help him make better decisions when buying technology for the Agency. This forum will expose him to hands on demonstrations and other professionals to network with in the IT field. COPTECH is grant funded so Corporal's registration, airfare (up to 425.00), hotel and meals will be paid for. Additional airfare and baggage fees will be paid for out of the Sheriff's Office Continuing Ed general ledger. **A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to approve out of state travel for Corporal Ken Carpenter to attend the COPTECH Forum in Charlotte, NC. The Historical Commission has received a donation for the Kyle Depot project and from the Harry L. Willett Foundation for the Buck Winn Mural Project. Amount required \$50 Kyle Depot Project; \$50,000 Buck Winn Murals Restoration Project. Line item number 141-676-00.4610 - \$50; 141-676-00.4614 - \$50,000. **A motion was made by Commissioner Ingalsbe, seconded by Commissioner Jones to accept donations for the Historical Commission Kyle Depot and Buck Winn Mural Restoration projects and amend the budget accordingly. 31374 SUB-463; SHOPS AT SUNFIELD III - REPLAT OF LOTS 7 & 8 (4 LOTS) GRANT A VARIANCE TO SECTION 721.5.07 OF THE HAYS COUNTY DEVELOPMENT REGULATIONS

County Planner, Caitlyn Hairell gave staff recommendation. Shops at Sunfield III was originally platted as 9 lots in 2014. The proposed replat of Lots 7 & 8, originally 12.27 and 7.01 acres, will create 4 new lots. Water service will be provided by GoForth Water Supply. Wastewater will be accomplished by the Sunfield MUD. Section 721.5.07 of the Hays County Development Regulations establishes criteria for determining if a development can utilize an easement instead of constructing a County maintained road. This section states that only developments which will be used for single family residences only shall be permitted to utilize a shared access driveway as means of access to a regulated roadway. The developer is requesting that the proposed lots 7A and 7B be allowed to utilize a shared access driveway as means of access. **A motion was made by Commissioner Jones, seconded by Commissioner Ingalsbe to approve SUB-463; Shops at Sunfield III - Replat of lots 7 & 8 (4 lots) grant a variance to Section 721.5.07 of the Hays County Development Regulations. All present voting "Aye". MOTION PASSED**



31375 AUTHORIZE THE COUNTY JUDGE TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT BETWEEN HAYS COUNTY AND BECERRA CORP DBA THE MANSKE ROLL CAFE FOR FOOD AND DINING SERVICES IN THE HAYS COUNTY GOVERNMENT CENTER

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Whisenant to authorize the County Judge to execute a Professional Services Agreement between Hays County and Becerra Corp DBA The Manske Roll Cafe for food and dining services in the Hays County Government Center. All present voting "Aye". MOTION PASSED

DISCUSSION OF ISSUES RELATED TO THE HAYS COUNTY JAIL, AND THE PLANNING OF PROJECTS PERTAINING TO THE PUBLIC SAFETY FACILITIES NEEDS WITHIN THE COUNTY

Judge Cobb gave the Hays County Jail Report. Hays County's current maximum jail capacity is 362 inmates. Jail Standards recommends holding approximately 10% of capacity open. That lowers our capacity to 311. The jail's daily average was 293 and peak was 300 on March 10th for the week of March 6 to March 12, 2016. The maximum female capacity is 76 inmates. Last week's average was 61 and peak was 65 on 3/10/2016. The maximum male capacity is 256 inmates. Last week's average was 232 and peak was 235 on 3/10/2016. Inmate at Guadalupe County: 34; Inmate at Bastrop County: 10; Inmate at Caldwell County: 32; Inmate at Walker County: 10.
