This is for the labor costs associated with installing the light and radar equipment for the new vehicle for FY 2016. Additional funds (\$420) are needed in order to capture the costs appropriately. Funds have been identified in the operating budget to cover the additional needed. Amount required \$540.00. Decrease Vehicle Maintenance & Repairs - (\$420); Increase Vehicles_Capital - \$420. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize payment of \$540.00 to Mike Vasil for the vehicle light package for Constable 2 in which no purchase order was obtained and amend the budget accordingly. 31501 BENEFIT PLAN AND AUTHORIZE PURCHASING TO SOLICIT FOR PROPOSAL AND ADVERTISE

A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to approve specifications for RFP 2016-P10 Consultant for Group Benefit Plan and authorize Purchasing to solicit for proposal and advertise. All present voting "Aye". MOTION PASSED

31502 AUTHORIZE THE COUNTY JUDGE TO EXECUTE A MEMORANDUM OF UNDERSTANDING (MOU) FOR ADDITIONAL FUNDING THROUGH THE U.S. MARSHALS SERVICE FOR SHERIFF'S OFFICE OVERTIME REIMBURSEMENTS

AND AMEND THE BUDGET ACCORDINGLY

Additional travel funds are needed for the Juvenile Probation Officer that oversees the Special Needs Diversionary Program due to a shortage in the Juvenile Probation fleet. This program provides specialized supervision for mental health juveniles in order to rehabilitate juvenile offenders and prevent them from penetrating further into the criminal justice system. Savings within the operating budget have been identified to fund this request. Amount required \$400.00; Decrease Youth Services 001-686-00.5360; Increase Travel 001-686-00.5501. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to amend the Juvenile Probation Office operating budget for additional travel funds related to the Special Needs Diversionary Program. All present voting "Aye". MOTION PASSED

31504 APPROVE UTILITY PERMITS

31505 AUTHORIZE THE COUNTY CLERK'S OFFICE TO PURCHASE A NEW LAPTOP FOR USE IN THE COUNTY COURT AT LAW COURTROOMS AND AMEND THE BUDGET ACCORDINGLY

The County Clerk's Office would like to purchase a new laptop for use in the County Court at Law courtrooms. Currently her staff and the Judge's staff are in the courtroom at the same time in which both are in need of accessing electronic files, and there is only one PC set up for this purpose. The additional laptop will allow her staff to utilize the equipment as needed in any of the courtrooms. Savings within her Records Management Fund are available to fund this request. Amount required \$1,285.00; Decrease Eqpt Maint & Repair 101-617-10.5411 (\$1,285); Increase Computer Equipment 101-617-10.5712_400 \$1,285. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to authorize the County Clerk's Office to purchase a new laptop for use in the County Court at Law courtrooms and amend the budget accordingly. All present voting "Aye". MOTION PASSED

31506 AMEND THE CONSTABLE PRECINCT 1 OPERATING BUDGET FOR UPGRADES NEEDED ON A M5300 SYSTEM DUAL CONTROL RADIO PACKAGE FOR A TRANSFERRED VEHICLE

On April 5, 2016 the Commissioner's Court approved a vehicle transfer for one Dodge Charger from the Sheriff's Office to the Constable in Precinct 1. In order to get this vehicle fully functionally, a mobile radio package needs to be installed. The Constable currently has a one-piece radio that needs to be converted to a two-piece in order to accommodate the needs. Savings within their operating budget have been identified to fund this request. Amount required \$1,245.00; Decrease Continuing Education 001-635-00.5551 (\$1,245); Increase Eqpt Maint & Repair 001-635-00.5411 \$1,245. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to amend the Constable Precinct 1 operating budget for upgrades needed on a M5300 System Dual Control Radio package for a transferred vehicle. AUTHORIZE THE COUNTY JUDGE TO EXECUTE A SUPPLEMENTAL AGREEMENT NO. 2 TO THE PROFESSIONAL SERVICES AGREEMENT WITH COBB FENDLEY & ASSOCIATES, INC. FOR UTILITY COORDINATION SERVICES IN HAYS COUNTY, INCREASING THE COMPENSATION CAP BY \$111,460.20 FROM \$612,997.14 TO \$724,457.34

The additional authorized money will allow for the execution of a supplemental #6 to Work Authorization #2 for FM 1626 South for the engineering and survey costs associated with the easement for the City of Buda. Amount required \$111,460.20; Line item 030-802-96-628.5623_400. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize the County Judge to execute a Supplemental Agreement No. 2 to the Professional Services Agreement with Cobb Fendley & Associates, Inc. for Utility Coordination Services in Hays County, increasing the Compensation Cap by \$111,460.20 from \$612,997.14 to \$724,457.34. All present voting "Aye". MOTION PASSED

VARIANCE FROM SECTION 10 C-1 OF THE HAYS COUNTY RULES FOR ON-SITE SEWAGE FACILITIES AND GRANT A DEVELOPMENT AUTHORIZATION TO THE OWNER OF 2.0 ACRES IN THE WILLIAM H VAN HORN SURVEY LOCATED OFF OF HUNTER ROAD IN PRECINCT 3

The owners of the subject tract lost their home in the Memorial Day flood of 2015. The owners chose not to rebuild and are acquiring 2.0 acres off of Hunter Road in Precinct 3, from a family friend, to construct a new home. They have applied for a permit to construct an On-Site Sewage Facility on the newly created parcel. Hays County Regulations do not allow staff to issue any permits on parcels not in compliance with platting requirements, however the owners have requested a variance from Section 10 C-1 of the Hays County Rules for On-Site Sewage Facilities. This variance would allow construction of the advanced septic system, so they can move into the previously constructed home. Staff recommends the court require owners to begin the platting process within 90 days of the variance being issued, and have the plat completed within six months of issuance. A motion was made by Commissioner Conley, seconded by Commissioner Whisenant accept a variance from Section 10 C-1 of the Hays County Rules for On-Site Sewage Facilities and grant a development authorization to the owner of 2.0 acres in the William H Van Horn Survey located off of Hunter Road in Precinct 3. All present voting "Aye". MOTION PASSED

In preparation for installing the recently approved replacement dishwasher, it was discovered that one of the 4 inch drain lines in the Jail kitchen that handles the main sink, dishwasher, and grease trap has deteriorated and separated into two pieces. These repairs need to be completed in order to operate these appliances and maintain a safe and clean environment. Amount required \$19, 916; TDIndustires SOW/Quote; TCPN Contract: R150501-TX-10009; Funds were budgeted during the FY 2016 budget process in County Wide (\$250k) for miscellaneous capital; improvements for the Jail as needed. To date a total of \$208,843 has been used for security panel upgrades and a replacement dishwasher, leaving an available balance of \$41,157 for this repair. Amount required: Decrease Co Wide - 001-645-00.5715_400 - (\$12,959); Decrease Co Wide - 001-645-00.5399 - (\$6,957); Increase Jail - 001-618-03.5741. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize the Sheriff's Office to approve the Scope of Work (SOW) from TDIndustries for Kitchen Drain Line repairs at the Jail Facility and amend the budget accordingly. DISCUSSION OF ISSUES RELATED TO THE HAYS COUNTY JAIL, AND THE PLANNING OF PROJECTS PERTAINING TO THE PUBLIC SAFETY FACILITIES NEEDS WITHIN THE COUNTY

Commissioner Ingalsbe gave the Hays County Jail report. Hays County's current maximum jail capacity is 362 inmates. Jail Standards recommends holding approximately 10% of capacity open. That lowers our capacity to 311. The jail's daily average was 282 and peak was 290 on April 24th for the week of April 24 to April 30, 2016. The maximum female capacity is 76 inmates. Last week's average was 55 and peak was 59 on 4/28/2016. The maximum male capacity is 256 inmates. Last week's average was 226 and peak was 234 on 4/24/2016. Inmate at Guadalupe County: 45; Inmate at Bastrop County: 0; Inmate at Caldwell County: 37; Inmate at Walker County: 2.

ACTION RELATED TO THE BURN BAN AND/OR DISASTER DECLARATION

Today's drought index is 50. Commissioner Ingalsbe advised that the Burn Ban will remain lifted. Commissioner Ingalsbe urged the citizens of Hays County to use extreme caution when conducting outdoor burning.
