## 32804 APPROVE THE INTERGOVERNMENTAL TRANSFER (IGT) OF LOCAL PROVIDER PARTICIPATION FUNDS (LPPF) FOR CENTRAL TEXAS MEDICAL CENTER AND SETON MEDICAL CENTER HAYS FOR DY 6 UNCOMPENSATED CARE (UC) PAYMENTS AS PART OF THE TEXAS HEALTHCARE TRANSFORMATION AND QUALITY IMPROVEMENT PROGRAM (1115 WAIVER)

A date for transfer of DY6 UC 1115 waiver funds was announced on August 14, 2017. All LPPF funds are collected from Hays County Hospitals and are budgeted. Though the IGT of these funds do not require specific Court approval, having them approved (If sufficient notice is given by the State) or ratified (if sufficient notice is



not provided by the State) ensures the Court and the public are informed of the process. IGT amount (settlement date of 9-7-17): \$832,998.13 CTMC amount: \$360,798.41 Seton Hays amount: \$472,199.72. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to approve the Intergovernmental Transfer (IGT) of Local Provider participation Funds (LPPF) for Central Texas Medical Center and Seton Medical Center Hays for DY 6 Uncompensated Care (UC) payments as part of the Texas Healthcare Transformation and Quality Improvement Program (1115 Waiver). #### 32805 ACCEPT A GRANT AWARD FROM THE OFFICE OF THE GOVERNOR, CRIMINAL JUSTICE DIVISION FOR FUNDING TO SUPPORT THE HAYS COUNTY VETERANS COURT IN THE AMOUNT OF \$77,576.00

On February 14, 2017 the Commissioners Court approved submission of a grant application and accompanying resolution to the Governor's Office, Criminal Justice Division for funding to support the Hays County Veterans Court. The Veterans Court provides a voluntary intensive treatment program for those military veterans who suffer from combat-related trauma and have been diagnosed with mental health issues, PTSD, or TBI, and have been arrested for a non-violent offense. The grant award is to continue the support and operations of the Court, and includes funding for a Court Coordinator, in-state and out-of-state travel and training expenses, office supplies, and contractual services including drug/alcohol testing, monitoring, and phone (land-line) service. The grant project period is from September 1, 2017 through August 31, 2018. The statement of award and required conditions for CJD recipients are attached and acceptance is done electronically. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to accept a Grant Award from the Office of the Governor, Criminal Justice Division for funding to support the Hays County Veterans Court in the amount of \$77,576.00. All present voting "Aye". MOTION PASSED

Stephen & Deborah Ohlman are proposing an OSSF to serve an automobile shrink wrap shop at 174 Distribution Cv., Buda in Precinct 2. This property is in the Park 35 South subdivision, Section 4B, Block C and lot 51 and water will be supplied by a public water supply. It also lies within City of Buda. The components of this on-site sewage facility will be a 1500 gallon three-compartment septic tank. After treatment, effluent will be dispersed to a low pressure dosage field. The system was designed by Stephen Jetton for a flow of 200 gallons per day. On February 7, 2017 Commissioners Court accepted a FY 17 Formula grant award from the Texas Indigent Defense Commission (TIDC) in the amount of \$129,892.00. This is a formula grant available annually to the

County to assist in the implementation of the provision of the Fair Defense Act (FDA) and improve the indigent defense system. Notification from TIDC indicating an increase to our current grant award was received and will be added to the final quarterly payments for FY17 formula grants which will be disbursed in November. Attached is the letter from TIDC stating increase to our current grant award. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to accept a Revised Award Amount for the FY 17 Formula Grant from the Texas Indigent Defense Commission for up to \$161,683.00 and amend the budget accordingly. ## 32811 AUTHORIZE THE EXECUTION OF A REVISED INTERLOCAL COOPERATION AGREEMENT BETWEEN HAYS COUNTY AND BURNET COUNTY FOR JAIL SERVICES

Effective October 1, 2017, Burnet County is increasing their rate for housing out of county inmates from \$35.00 per day to \$40.00 per day. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to authorize the execution of a Revised Interlocal Cooperation Agreement between Hays County and Burnet County for Jail Services. ## 32813 AUTHORIZE PAYMENT TO G.Q.F MANUFACTURING FOR EXTENSION PROGRAM SUPPLIES, WHERE NO PURCHASE ORDER WAS ISSUED OR QUOTES OBTAINED AS REQUIRED PER THE COUNTY PURCHASING POLICY AND AMEND THE BUDGET ACCORDINGLY

The Extension Office purchased supplies for the youth agriculture programs and did not obtain a purchase order per County Purchasing Policy. #### 32817 AUTHORIZE AND RATIFY EXPENDITURES RELATED TO THE SHERIFF'S OFFICE DEPLOYMENT OF COUNTY LAW ENFORCEMENT OFFICERS TO THE CITY OF PORT ARANSAS FOR HURRICANE HARVEY ASSISTANCE

The Sheriff is requesting approval to utilize county resources to assist areas that have been affected by Hurricane Harvey. A total of nine officers (two command staff and seven deputies) and one maintenance staff member will be deployed to the City of Port Aransas. The command staff will arrive on Thursday, August 31st for logistics purposes and prepare the necessary equipment for the deputy's arrival. The deputies and maintenance staff will arrive on Friday, September 1st. The Hays County law enforcement officers will assist the city police with patrol duties, enforcing curfew, and responding to calls for service. The maintenance staff will assist with vehicle and maintenance duties as needed during the deployment. All staff will remain available for assistance through Sep. 8th, return to Hays County for a one day off period on the 9th, returning to the City of Port Aransas on the 10th for additional assistance as needed through September 15th. Savings within the Sheriff's operating budget will be identified for costs associated with the disaster assistance. If additional funds are required, a budget amendment item will be submitted to the court for approval. The Sheriff's budget coordinator will work with the Auditor's Office to track all expenses related to the hurricane assistance. **A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize and ratify expenditures related to the Sheriff's Office deployment of County law enforcement officers to the <b>City of Port Aransas for Hurricane Harvey assistance.** All present voting "Aye". **MOTION PASSED** 

### 32818 AUTHORIZE A NEW LEASE CONTRACT WITH RICOH FOR A COPIER/FAX MACHINE FOR THE CONSTABLE PRECINCT 3 OFFICE AND AMEND THE BUDGET ACCORDINGLY

The Constable Precinct 3 office currently shares a copier/fax machine with other Precinct 3 departments. This lease will be for Constable Precinct 3's use and will be effective September 1, 2017 in preparation of the offices move to the new building. Funds for one full year's lease payments will need to be budgeted for FY18 prior to adoption if the lease contract is approved. ### 32819 AUTHORIZE THE SUBMISSION OF A GRANT APPLICATION TO THE OFFICE OF THE GOVERNOR, CRIMINAL JUSTICE DIVISION FOR RIFLE-RESISTANT BODY ARMOR FOR LAW ENFORCEMENT OFFICERS (SHERIFF'S DEPARTMENT) IN THE AMOUNT OF \$108,976.00

During the recent session, the legislature passed, and the Governor signed Senate Bill 12 to increase the safety of Texas Law Enforcement Officers that resulted from the Dallas Texas shooting incident that left five police officers dead. Senate Bill 12 authorizes up to \$25 million in funding to assist agencies with purchasing rifle-resistant vests for law enforcement officers. If awarded, we are requesting for 139 rifle-resistant vests at \$784.00 per vests for a total of \$108,976.00 for Officers within Hays County Sheriff's Office. No match is required. The grant period is for one year after the contract execution date. The application is submitted electronically and is due on or before September 6, 2017. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize the submission of a grant application to the Office of the Governor, Criminal Justice Division for rifle-resistant body armor for law enforcement officers (Sheriff's Department) in the amount of \$108,976.00. All present voting "Aye". MOTION PASSED

## 32820 CALL FOR A PUBLIC HEARING ON SEPTEMBER 19, 2017 TO EXTEND THE 35 MPH SPEED LIMIT ZONE ON SAWYER RANCH ROAD NEAR HIGHPOINTE SUBDIVISION TO APPROXIMATELY 200 FEET SOUTH OF THE ENTRANCE TO MEADOW CREEK RANCH SUBDIVISION

This action would decrease the existing 50 MPH speed limit in front of Meadow Creek Ranch subdivision to 35 MPH. Water service will be provided by West Travis County Public Utility Agency and wastewater treatment will be accomplished by individual on-site sewage facilities. Hays County Clerk, Liz Q. Gonzalez spoke. The County Clerk would like to begin the preservation of birth records utilizing Kofile Technologies for off sight management and preservation. The proposed preservation services include conservation, de-acidification, mending, encapsulation, binding, archival imaging, security backups on microfilm, indexing, and two units of archival shelving. Dedicated funds within the County Clerks Records Management and Archive Fund are available to fund this project. Increase 101-617-11 Decrease 101-617-10. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize the County Clerk to utilize Kofile Technologies for Phase I of the Preservation of Vital Records project and amend the budget accordingly. 32824 ADOPT A RESOLUTION IN SUPPORT OF A COMBINED EMERGENCY COMMUNICATIONS CENTER AND PUBLIC SAFETY ANSWERING POINT (PSAP) THAT WILL PROVIDE 911 CALL TAKING AND DISPATCH SERVICES FOR HAYS COUNTY, KYLE POLICE DEPARTMENT, BUDA POLICE DEPARTMENT AND THE RESPECTIVE FIRE AND EMS PROVIDERS OF ALL EMERGENCY SERVICE DISTRICTS IN THE COUNTY

Chief of Staff, Lon Shell spoke. For approximately ten years various working groups and committees have developed plans for a county wide emergency communications system and PSAP. A Report of Findings and Observations was completed and submitted to the County in November 2014 (see attached) that details the efforts up to that point. Since then, Hays County, the City of San Marcos, the City of Buda, the City of Kyle, San Marcos Hays County EMS, and all of the Emergency Service Districts and their respective providers in the County have worked on strategies in which a combined PSAP could be implemented. Last year the voters of Hays County approved a Public Safety Bond that provided for the construction of a building that will include an Emergency Communications facility and infrastructure. During the development of the Bond program, Hays County, the City of Kyle and the City of Buda began more detailed discussions on combining two existing PSAP's (the city of Kyle's and Hays County's) and associated 911 call taking into a Combined Emergency Communications Center (CECC). The proposed CECC will provide dispatching services for Kyle PD and all of the agencies currently served by Hays County, which include; Buda PD, Hays County SO, Hays County Constables, San Marcos Hays County EMS (outside of the city of San Marcos), South Hays Fire, Kyle Fire, Buda Fire and EMS, Wimberley Fire, Wimberley EMS, North Hays County Fire and Rescue, and Chisolm Trail Fire and Rescue. Benefits of the development of the Combined Emergency Communications Center include: -Sharing of resources and infrastructure -Unification of 911 call taking for all Hays County agencies except San Marcos PD/ Fire, and Texas State -911 calls will not have to be transferred -Dedicated job functions. -Standard operating procedures for call taking and dispatching among all participating agencies -All participating dispatch agencies will utilize the same Computer Aided Dispatch (CAD) system. A motion was made by Commissioner Conley, seconded by Commissioner Whisenant to adopt a resolution in support of a Combined Emergency Communications Center and Public Safety Answering Point (PSAP) that will provide 911 call taking and dispatch services for Hays County, Kyle Police Department, Buda Police Department and the respective Fire and EMS providers of all Emergency Service Districts in the County. All present voting "Aye". MOTION PASSED

Today's Drought Index – 133. Fire Marshall recommends the Burn Ban remain lifted.
