# 33042 APPROVE OUT OF STATE TRAVEL FOR RENEE LUNA TO ATTEND THE FORENSIC EXAMINATION OF VIOLENT CRIME SCENES IN OCEANSIDE, CALIFORNIA

Out of state travel is needed to send Renee Luna to attend the Forensic Examination of Violent Crime Scenes Course in Oceanside, California on December 4-6, 2017. As a Criminalist for the Sheriff's Office, Ms. Luna's attendance to this advanced course will allow her to partake in practical applications of several techniques that are important to Crime Scene Examination and reconstruction of violent crimes. She will be exposed to topics such as Stain Recognition, Angle of Impact determination, Specialized Photography, Painting with light, Shooting Reconstruction and many others. This training will also allow Ms. Luna to network with other criminalists across the nation. Registration, flight expenses, hotel fees, rental car and per diem will be paid out of the Sheriff's Office Continuing Ed general ledger. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to approve out of state travel for Renee Luna to attend the Forensic Examination of Violent Crime Scenes in Oceanside, California. # 33043 AUTHORIZE THE EXECUTION OF A RESOLUTION AND SUBMIT A GRANT APPLICATION TO THE TEXAS INDIGENT DEFENSE COMMISSION FOR UP TO \$125,002.00

This is a formula grant available annually to the County to assist in the implementation of the provision of the Fair Defense Act (FDA) and improve the indigent defense system. The funds can be used for investigator expenses, attorney fees, and expert witness expense incurred by the County on criminal indigent cases. The grant application is submitted through an on-line electronic process with the Resolution e-mailed for verification authorization. The grant amount is an estimate at this time based on previous award and will be finalized upon grant award. The funding period for this grant is October 1, 2017 through September 30, 2018. A motion was made by Commissioner Shell, seconded by Commissioner Whisenant to authorize the execution of a resolution and submit a grant application to the Texas Indigent Defense Commission for up to \$125,002.00. It is imperative that this position be available to staff and supervisors in order to remain productive and perform duties effectively. Budget Amendment: Increase Telephone Allowance .5194 and Decrease Telephone Expense .5489. A motion was made by Commissioner Shell, seconded by Commissioner Whisenant to authorize the Building Maintenance Department at add a telephone allowance effective November 1, 2017 for the Facility Maintenance position, slot number 0200-004 and amend the budget accordingly. 33046 ACCEPT A DONATION OF \$1,000 TO HAYS COUNTY FROM GREGG AND REBECCA REYES

To facilitate Hays County's and Kyle's negotiation with owners of the pending Water Ridge subdivision, formerly Blanco River Ranches subdivision, PID Works recently performed analysis regarding valuation of anticipated improvements associated with the development. Although the analysis does offer a public benefit to the County, Mr. Reyes agreed to donate \$1,000 to Hays County to reimburse the County for the expense of this analysis. A motion was made by Commissioner Shell, seconded by Commissioner Whisenant to accept a donation of \$1,000 to Hays County from Gregg and Rebecca Reyes. All present voting "Aye". MOTION PASSED

AUTHORIZE THE EXECUTION OF A CONSTRUCTION AGREEMENT WITH JB CONSTRUCTION FOR RENOVATIONS TO THE FORMER CAFÉ SPACE AT THE HAYS COUNTY GOVERNMENT CENTER AND AUTHORIZE THE EXECUTIVE DIRECTOR OF COUNTYWIDE OPERATIONS TO SIGN CHANGE ORDERS THAT MAY ARISE DURING PROJECT, NOT EXCEEDING 10% OF TOTAL PROJECT COST

The Elections Department is in need of office/workspace that is able to accommodate their needs in one area. They currently use multiple locations during elections to perform the necessary tasks vital to the election process. The area dedicated to café space located at the Hays County Government Center is currently vacant and can be renovated to suit their needs. The funds to cover the project were awarded in the FY'18 budget year. A motion was made by Commissioner Shell, seconded by Commissioner Whisenant to authorize the execution of a construction agreement with JB Construction for renovations to the former café space at the Hays County Government Center and authorize the Executive Director of Countywide Operations to sign change orders that mays arise during project, not exceeding 10% of total project cost. The subdivision will be served by individual water wells and rainwater collection. Wastewater treatment will be accomplished by individual on-site sewage facilities. Dan Lyon, Rodrigo Amaya, Harvey Jenkins, Commissioner Jones, Commissioner Shell, and Commissioner Whisenant spoke. Luanne Caraway was nominated on September 5, 2017. APPROVE THE GUARANTEED MAXIMUM PRICE ("GMP") PROPOSED FROM TURNER CONSTRUCTION COMPANY, CONSTRUCTION MANAGER AT RISK ("TURNER"), ON OCTOBER 24, 2017, FOR THE WORK RELATED TO THE HAYS COUNTY PUBLIC SAFETY BOND PROGRAM PHASE II; AND TO ACCEPT SAID PROPOSAL, DECLARE IT UNACCEPTABLE, ALLOW TURNER TO WITHDRAW THE GMP PROPOSAL AND DELIVER IT AT A LATER DATE, OR TAKE OTHER APPROPRIATE ACTION

General Counsel, Mark Kennedy spoke. Guaranteed Maximum Price (GMP) Proposal Phase II: Jail Addition and Renovation, Public Safety Building, Training Facility. Turner Construction Company delivered the GMP for Phase II to Commissioners Court on October 24th. The GMP proposal as delivered was \$7,152,634 over the approved Construction Cost Limitation (CCL) for the project. Turner presented a path of potential VE items and alternates that would decrease the cost within the CCL; however, the Hays County Sheriff's Office and Building Committee do not recommend the proposed alternates included in the path forward. If Hays County does not accept Turner's GMP proposal, it may seek Competitive Sealed Proposals from 3rd parties while keeping Turner's GMP on hold for 90 days. No action taken.
