Vilma Resendez, Pastor of the Pentecostal Church, gave the invocation. Commissioner Ingalsbe led the court in the Pledge of Allegiance to the United States and Texas flags. Commissioner Ingalsbe called the meeting to order.

PUBLIC COMMENTS

Dan Lyon – San Marcos resident, Harvey Jenkins – San Marcos resident, and Pamela Carroll – Director of Girl Scouts of Central Texas, all made public comments.

PRESENTATION OF A REMOTE UNDERWATER VEHICLE BY OFFICE OF EMERGENCY SERVICES AND SAN MARCOS AREA RECOVERY TEAM

Irene Salazar and Morgan Carpenter, students at San Antonio College, gave a powerpoint presentation. The Office Of Emergency Services in conjunction with San Marcos Area Recovery Team (SMART) assisted a student led STEM team from San Antonio College in the design, research, implementation and testing of a Remote Underwater Vehicle (RUV). The students designed the RUV to aid in underwater recovery operations for Law Enforcement purposes and Search and Rescue operations. The team's Phase I RUV design has won multiple awards in STEM competitions throughout the US and is currently in Phase II. In Phase II the STEM team plans on implementing new features and tools to better equip Public Safety Dive teams and Search and Rescue Operations and aid in keeping first responders safe.

PRESENTATION RECOGNIZING THE COUNTY CLERK'S OFFICE FOR RECEIVING THE FIVE STAR EXEMPLARY AWARD

Liz Q. Gonzalez, Hays County Clerk spoke. This is an award that the Texas Department of State Health Services Vita Statistics Unit gives out yearly. The criteria varies slightly from year to year. Some of the requirements are reporting on: Self-Assessment Survey, Remote Birth Access System, Timeliness, Training & Participation, and Birth Registration. In the past, the County Clerk's Office has received the Five-Star Award. This year we received the Five-Star Exemplary Award. 33183 AUTHORIZE COMMERCIAL OSSF PERMIT AT 2780 W HIGHWAY 290, DRIPPING SPRINGS, TEXAS 78620

The Denbow Company, Inc. is proposing an OSSF to serve three office/warehouse buildings that will accommodate up to 20 employees. This 3.421-acre tract of land will be served by a rainwater collection system. The system designer, Dan Balboa, R.S., has designed a non-standard treatment system, which consists of pretreatment, flow-equalization, and secondary treatment. After treatment, the effluent will be dispersed via surface application for a maximum daily rate of 180 gallons. The low water crossing monitoring equipment at the Lime Kiln Rd crossing was recently damaged in a roll over vehicle collision; additionally equipment at the Uhland Rd crossing was damaged inadvertently by the property owner while cleaning up debris in the river bed. Both sites are now inoperable and require repairs in order to regain full functionality. The Emergency Services Director has received quotes from our current LWC installation vendor to complete both repairs. Hays County will be seeking reimbursement from at fault parties; however it is imperative that these repairs are completed in a timely manner for safety reasons. Funding from County-Wide self-insurance is available to fund this request. Any reimbursements received will be deposited back into that g/l account. Transportation Director, Jerry Borcharding, gave staff recommendation. La Cima Ph. 1 is a proposed 139 lot subdivision located along RR 12 in PCT 3. Water and wastewater service will be accomplished by the City of San Marcos. La Cima PH 1 Subdivision has been reviewed under the Interlocal Cooperation Agreement with the City of San Marcos and has been approved by County staff. While the plat has been approved administratively, formal acceptance of fiscal surety is required by Commissioners Court action. **A motion was made by Commissioner Shell, seconded by Commissioner Whisenant to accept Letter of Credit No. 5132 for street and drainage improvements for SUB-677, La Cima Ph. 1 in the amount of \$1,488,723. Commissioner Jones spoke. A motion was made by Commissioner Jones, seconded by Commissioner Ingalsbe to adopt a Resolution of support for the submittal of the railroad siding relocation project, as part of the City of Kyle's application to the Capital Area Metropolitan Planning Organization (CAMPO). All present voting "Aye". MOTION PASSED

33204 AUTHORIZE THE EXECUTION OF A CONTRACT WITH HDR ENGINEERING, INC. FOR SERVICES RELATED TO THE EVALUATION OF ENVIRONMENTAL CONSTRAINTS AND ROUTE ALTERNATIVES FOR THE MOUNTAIN CITY LOOP

Commissioner Jones, and General Counsel, Mark Kennedy spoke. An alternate route connecting FM 1626 at the Buda Truck Bypass to FM 150 which bypasses Jack C. Hays Trail (FM 2770) and Hays High School has been contemplated by the County for many years. As a result the proposed loop was included in the County Transportation Plan adopted in 2013. This action will permit the first step in the development of the project, feasibility and route alternative analysis, to begin. The contract cost exceeds \$50,000, and will be subject to Discretionary Exemption under Local Government Code 262.024. A motion was made by Commissioner Jones, seconded by Commissioner Shell to authorize the execution of a contract with HDR Engineering, Inc. for services related to the evaluation of environmental constraints and route alternatives for the Mountain City Loop. All present voting "Aye". MOTION PASSED

33205 AUTHORIZE THE COUNTY JUDGE TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT (PSA) WITH M & S ENGINEERING FOR PHASE 1 SERVICES FOR THE DESIGN OF IMPROVEMENTS TO LOW WATER CROSSINGS LOCATED AT SYCAMORE AND BEARS CREEKS LOCATED IN PCT 4

Commissioner Whisenant spoke. This action will provide preliminary design alternatives for upgrades to crossing that frequently flood on Sycamore Creek and Bear Creek in Pct 4. A motion was made by Commissioner Whisenant, seconded by Commissioner Shell to Authorize the County Judge to execute a Professional Services Agreement (PSA) with M & S Engineering for phase 1 services for the design of improvements to low water crossings located at Sycamore and Bears Creeks located in Pct. 4. All present voting "Aye". MOTION PASSED

33206 AUTHORIZE THE COUNTY JUDGE TO EXECUTE A CONTRACT WITH HDR ENGINEERING, INC. FOR THE PREPARATION OF A PRELIMINARY ENGINEERING REPORT AND FINAL DESIGN OF THREE LOW WATER CROSSINGS ON HOG CREEK IN PRECINCT 3

Commissioner Shell spoke. The City of Woodcreek in western Hays County has experienced flooding of residential streets and homes with the high intervals of flash flooding events experienced throughout the region in recent years. Cypress Creek serves as the main drainage way of the area and also acts as a focal point for the residents with small, spring fed ponds serving as water feature amenities for the area. Hog Creek is one of the larger tributaries to Cypress Creek and traverses through the center of the Woodcreek urbanized area. This tributary has been the primary flooding source of the homes and roads affected in Woodcreek. This proposed project will consist of two phases. Phase I – Preliminary Engineering, will include performing a preliminary engineering report to evaluate structural alternatives to reduce flooding including channelization, improvements to low water crossings, and a cursory review of previous detention alternatives developed previously by others. Phase II – Final Design will include final design of three (3) low-water crossing replacement structures (Hog Creek at Brookmeadow Dr., Brookhollow Dr., and Woodcreek Dr.) with hydraulically adequate structures complying with current Hays County street and drainage design requirements. The contract cost exceeds \$50,000, and will be subject to Discretionary Exemption under Local Government Code 262.024. A motion was made by Commissioner Shell, seconded by Commissioner Whisenant to Authorize the County Judge to execute a contract with HDR Engineering, Inc. for the preparation of a Preliminary Engineering Report and final design of three low water crossings on Hog Creek in Precinct 3. All present voting "Aye". MOTION PASSED

33207 SUB-907; EWING RAE SUBDIVISION (1 LOT) APPROVE THE FINAL PLAT

Hays County Planner, Caitlyn Strickland gave staff recommendation. Ewing Rae Subdivision is a proposed 2.322 acre lot located along Mt. Sharp Rd. Water service will be provided by private wells and wastewater service will be accomplished by individual OSSF.
