WITH VALERIE VALDEZ, DEPUTY CLERK, BEING PRESENT THROUGH VIDEO CONFERENCE THE FOLLOWING PROCEEDINGS WERE HAD, THAT IS:

Chaplain Javier Maldonado, 7th Day Adventist Church, gave the invocation. Judge Becerra led the court in the Pledge of Allegiance to the United States and Texas flags. Judge Becerra called the meeting to order.

PUBLIC COMMENTS

Hayden Matz, Hays County resident, gave a public comment in regards to transparency and united leadership by the court during the Covid-19 pandemic. Dan Lyon, Hays County resident, gave public comments, stating government should cut effective tax rates for homeowners and small landowners, and he read the Hays County disbursements. Rodrigo Amaya, Hays County resident, gave a public comment to the court to hire qualified people, and concerns about General Counsel.

UPDATE FROM THE COUNTY JUDGE AND STAFF REGARDING THE LOCAL DISASTER DECLARATION AND COVID-19. POSSIBLE DISCUSSION MAY FOLLOW.

Eric Schneider, Med, Epidemiologist, gave the court an update listing the areas of the active, pending, and negative test to-date. He announced there is community spreading of the virus. The Commissioners and Judge thanked the Health department for their work. Alex Villalobos, Chief of Staff and Emergency Management Coordinator, gave the court an update on the inventory of personal protective equipment (PPE) and chemicals used for disinfecting. He also spoke about possible locations that may be used in the event that the hospitals reach capacity. Judge Becerra gave announced a list of test site throughout the county. He also recommended using face masks. Rodrigo Amaya, Hays County resident, made a public comment stating he is worried about qualified personnel working in Hays County offices. **No action taken.**

A motion was made by Commissioner Jones seconded by Commissioner Shell to authorize the County Judge to execute Work Authorization #4 to the Professional Service Agreement (PSA) between Hays County and Bowman Consulting Group, Ltd. for the Cotton Gin road improvements project, and declare an exception to competitive procurement under Section 262.024(a)(4) of the Texas Local Government Code. A motion was made by Commissioner Jones seconded by Commissioner Ingalsbe to authorize the County Judge to execute an agreement between Hays County and Plateau Land & Wildlife Management in the amount of \$3,188.24 for the renewal of the 2020 Annual Service Agreement. All present voted "Aye." MOTION PASSED.

35039 AUTHORIZE THE SHERIFF'S OFFICE TO ACCEPT A DONATION OF \$200.00 AND AMEND THE BUDGET ACCORDINGLY.

A motion was made by Commissioner Jones seconded by Commissioner Ingalsbe to authorize the Sheriff's Office to accept a donation of \$200.00 and amend the budget accordingly. All present voted "Aye." MOTION PASSED.

35040 AUTHORIZE PAYMENT OF \$522.80 TO FEDEX FOR SHIPPING FEES WHERE NO PURCHASE ORDER WAS IN PLACE AS PER THE COUNTY PURCHASING POLICY.

A motion was made by Commissioner Jones seconded by Commissioner Ingalsbe to Authorize payment of \$522.80 to FEDEX for shipping fees where no purchase order was in place as per the County Purchasing Policy. All present voted "Aye." MOTION PASSED.

Commissioner Ingalsbe spoke about the grant for this item. A motion was made by Commissioner Ingalsbe seconded by Commissioner Jones to accept \$10,000.00 in grant contributions on behalf of the Hays County Child Protective Board and amend the budget accordingly. All present voted "Aye." MOTION PASSED.

35042 APPROVE AN AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT BETWEEN HAYS COUNTY AND BURNET COUNTY FOR JAIL SERVICES RELATED TO AN INCREASE IN COSTS FOR HOUSING AND CARE OF HAYS COUNTY INMATES.

Dan Lyon, Hays County resident, made a public comment against this item asking the court to vote no on the increase of costs. A motion was made by Commissioner Ingalsbe seconded by Commissioner Shell to approve an Amendment to the Interlocal Cooperation Agreement between Hays County and Burnet County for Jail Services related to an increase in costs for housing and care of Hays County inmates. Commissioner Ingalsbe, Commissioner Jones, Commissioner Shell, and Commissioner Smith voted "Aye." Judge Becerra voted "No." MOTION PASSED.

35043 APPROVE THE FILING OF TAX ASSESSOR-COLLECTOR JENIFER O'KANE'S CONTINUING EDUCATION TRANSCRIPT AS REQUIRED BY SECTION 6.231 (D) OF THE TEXAS PROPERTY TAX CODE.

A motion was made by Commissioner Jones seconded by Commissioner Shell to approve the filing of Tax Assessor-Collector Jenifer O'Kane's Continuing Education Transcript as required by Section 6.231 (d) of the Texas Property Tax Code. All present voted "Aye." MOTION PASSED.

35044 APPROVE THE REQUEST MADE BY LEIF JOHNSON FORD TRUCK CITY FOR WAIVER OF PENALTIES AND INTEREST ON TWO PROPERTY TAX PAYMENTS, CITING SECTION 33.011(H) OF THE TEXAS PROPERTY TAX CODE.

Dan Lyon, Hays County resident, gave a public comment, against the waiver of penalties. Jennifer O'Kane, Tax-Assessor-Collector, spoke on this item giving the court a summary of the events that took place. She stated the County had made a change to their account number that the taxpayer was unaware of, but once notified the payers processed the payment with the updated information. A motion was made by Commissioner Jones seconded by Commissioner Shell to approve the request made by Leif Johnson Ford Truck City for waiver of penalties and interest on two property tax payments, citing Section 33.011(h) of the Texas Property Tax Code. All present voted "Aye." MOTION PASSED.



35045 APPROVE THE WAIVER OF PENALTIES AND INTEREST ON E-CHECK PAYMENTS OF PROPERTY TAXES THAT RECEIVED NO CERTIFIED MAIL 'RETURN NOTICE', AS IS THE TAX OFFICE POLICY.

Jennifer O'Kane, Tax Assessor-Collector, stated there was an issue with a vendor, and that she believed the County should waive the penalties and interest for this particular instance. A motion was made by Commissioner Jones seconded by Commissioner Ingalsbe to approve the waiver of penalties and interest on E-Check payments of property taxes that received no certified mail 'return notice', as is the Tax Office policy. All present voted "Aye." MOTION PASSED.

35046 RATIFY THE SUBMISSION OF A GRANT APPLICATION WITH THE DEPARTMENT OF STATE HEALTH SERVICES (DSHS) FOR THE FY2020 COVID-19 CRISIS COAG GRANT IN THE AMOUNT UP TO \$150,839.00.

A motion was made by Commissioner Jones seconded by Commissioner Ingalsbe to ratify the submission of a grant application with the Department of State Health Services (DSHS) for the FY2020 COVID-19 Crisis CoAg Grant in the amount up to \$150,839.00. All present voted "Aye." MOTION PASSED.

All present voted "Aye." MOTION PASSED.

Alex Villalobos, Chief of Staff and Emergency Management Coordinator, spoke on this item in regards to quotes for PPE. Scott Raven, Fire Marshall, stated the current process for procuring PPE and other inventory needed is lengthy and causes missed opportunities for this pandemic. The Judge and Commissioners agreed that the Auditor and other department directors should take action at this time. They were tasked to list items, an increased limit to purchase supplies, and a list of names authorized to purchase such items. Credit card limits are going to be increased to \$5,000.00 for Alex Villalobos, Scott Raven, and Raul Reyes to include such things as face masks and eye protection. The Auditor also made a recommendation to move \$75,000.00 from contingency to cost center. A motion was made by Commissioner Jones seconded by Commissioner Shell to approve procurement & budget policies related to the COVID-19 pandemic and amend the budget accordingly.
