### Recommended Mailing Dates for Voted Ballots in 2023

From Iraq, Afghanistan, Deployed Naval Vessels	4 weeks before the election
From Other Overseas Military Installations	3 weeks before the election
From Other Overseas locations	4 weeks before the election (depending on foreign mail service)
From within the United States	1 week before the election
Federal Write-In Absentee Ballot	4 weeks before the election

# Instructions for Texas

Please review, print, sign and submit your completed FPCA to your local election official at the address provided below.



Sign and date. No witness signature required.

**Step 1:** Review your completed FPCA before printing.

**Step 2:** Print and Sign your FPCA.

**Step 3:** Send your election materials: This document package includes the FPCA to send to your election official as well as reference material. Please send only your FPCA.

## Where to Send

**Mail your FPCA:** Once your FPCA is complete, sign and date the form. Mail your FPCA directly to your election official.

**E-mail your FPCA:** Once your FPCA is complete, sign and date the form. Scan the signed FPCA into your computer. E-mail this package directly to your election official.

**Fax your FPCA:** Once your FPCA is complete, sign and date the form. Fax your FPCA directly to your election official. You may use the DoD Fax Service to fax your FPCA if you do not have access to a fax machine to fax your election official directly. Instructions for the DoD Fax Service are in the "Important Information" section or online at [FVAP.gov](http://FVAP.gov).

**\*\*\*IMPORTANT NOTE:** A timely faxed FPCA must be followed with a hardcopy mailed FPCA that must be received by the early voting clerk by the fourth business day after the fax. This rule does not apply to an e-mailed FPCA. *Texas strongly recommends using e-mail transmission instead of faxing if you wish to use the fastest delivery method for your FPCA.*

You can submit the FPCA by mail, e-mail, or fax (fax only if you are within a hostile fire area). **IMPORTANT NOTE FOR FAXING THE FPCA:** A timely faxed FPCA must be followed with a hardcopy mailed FPCA that must be received by the early voting clerk by the fourth business day after the fax. This rule does not apply to an e-mailed FPCA. *Texas strongly recommends using e-mail transmission instead of faxing if you wish to use the fastest delivery method for your FPCA.*

To find out the status of your FPCA, contact your election official. Your election official will contact you if your FPCA is not accepted.
