Education and/or Experience

- Five years experience in road maintenance and construction preferred or any equivalent combination of experience and training.

Other Qualifications, Certificates, Licenses, Registrations

- Class "A" Commercial Texas Driver's License preferred.
- Class "B" Commercial Texas Driver's License required or acquired by end of 6 month probationary period.
- Employees must provide and wear slip on safety boots, as described in the Hays County Safety Boot Policy for Road and Bridge.

Responsibilities

- Manages crews of road maintenance workers.
- Oversees and sometimes performs the road maintenance and construction functions such as paving, patching, crack sealing, constructing road bases, mowing, cleaning drainage areas, and hauling materials and debris.
- Establishes daily work schedules for maintenance crews.
- Determines methods and equipment to be used to accomplish tasks and projects.
- Oversees general maintenance of equipment.
- Monitors and inspects work in progress.
- Assess the adequacy of staffing and equipment levels.
- Ensures that plans are correctly followed, and the proper methods are being used.
- Orders materials and supplies.
- Ensures that deadlines are met.
- Ensures that safety standards and procedures are followed.
- Trains employees in proper procedures and maintenance/construction techniques.
- Communicates with the public about job schedules, job sites, and problems.
- Performs other duties as assigned.
- Utilize a smart-phone for a variety of tasks involving social media, the internet and on-screen applications.
- Communicates with the public, contractors, vendors, municipalities, office & management staff with a smart-phone using email and texting.
- Monitors changing weather conditions & forecasts with applications on a smart-phone.
- Uses the camera on a smart-phone for immediate capture and delivery of real-time road issues.
- Uses the smart-phone to provide immediate response time during emergencies.
- Accesses the departmental road work order program through the use of a smart-phone.
- Coordinates schedules, meetings, deadlines for road project-related issues using the smart-phone calendar application.
- Performs other duties as assigned.

Summary

Under limited supervision, oversees road and bridge maintenance and construction operations in Hays County.
