- Ensures security and safety of Judges, court staff, court participants, and the general public.
- · Executes arrest warrants.
- Transport arrestee to jail or court.
- Prepares courtroom for trials and hearings.
- Responsible for care, custody and control of jurors assigned to County Courts at Law.
- Calls witnesses to appear.
- \bullet Enforces courtroom rules of behavior.
- Warns and removes persons disturbing court procedures.
- · Prevents courtroom entry during jury charge.
- · Announces judge's entry.
- Prepares warrants.
- Assists Judges and court staff with daily court activities, including but not limited to calling dockets, impaneling juries, scheduling cases and researching legal issues.
- Supports other staff in office duties when court is not in session.
- Provides public assistance to the general public.
- Participates in training as assigned on subjects such as courtroom security, state and local criminal, civil and traffic laws, and traffic enforcement, including vehicle stop and approach techniques, and the proper use or radar units.
- Coordinates emergency response plans with Government Center Security, law enforcement representatives, and the emergency management department.
- · Effectively utilizes resources available to perform the job.
- Maintains TCOLE certification through approved training.
- Assures the services delivered by the Constable's office meets quality and timeliness standards.
- Enforces traffic laws including school zones, construction zones, subdivisions and County roads as needed.
- Prepares written and oral reports and presentations.
- Follows up on cases being investigated and assists other agencies (e.g. Fire, EMS, Department of Public Safety and other public safety agencies) and testifies in courts as needed
- Maintains patrol vehicle and equipment issued.
- Observes activities and initiates appropriate actions while on patrol.
- Responds to major traffic accidents and assists medical personnel as needed.
- Answers civil questions and assists public with non-law enforcement related problems.
- · Performs other duties as assigned.

Summary

Under general supervision, the Deputy Constable - Bailiff maintains security inside and outside of courtrooms and performs Court Bailiff duties. The Deputy Constable – Bailiff executes criminal arrest warrants and transports arrestees to jail or court. This position enforces all civil, criminal, and traffic laws of the State of Texas and Hays County. The Deputy Constable - Bailiff assists other agencies (e.g. Hays County Sheriff's Department, San Marcos Police, Kyle Police, Buda Police, Texas Highway Patrol, University Police, and other public safety agencies) to protect the citizens of Hays County and anyone traveling through Hays County. Individuals in this position serve at the pleasure of the current elected official. The Deputy Constable – Bailiff is not included in the Hays County Collective Bargaining Agreement (Bargaining Unit) per Article 2 Section 2.
