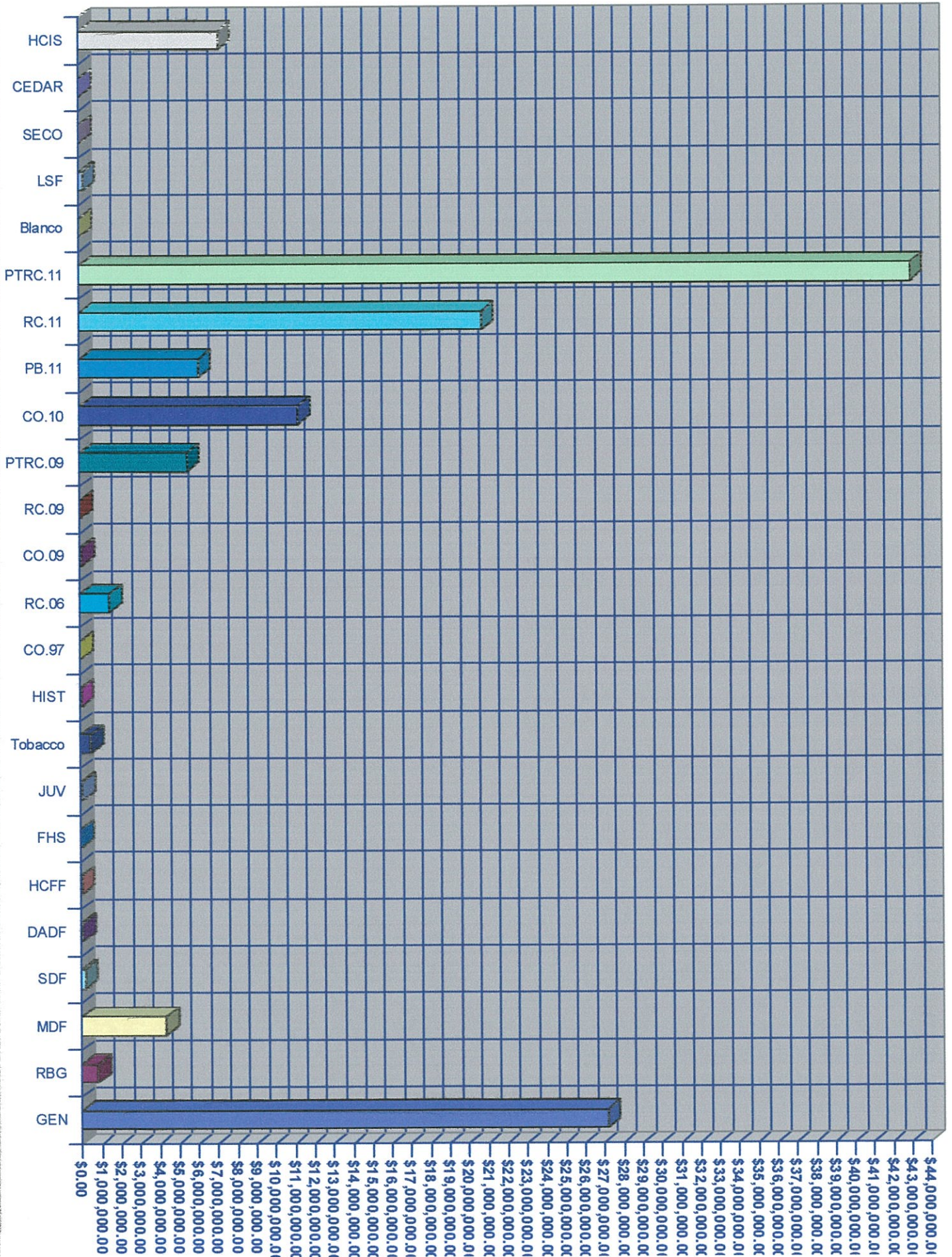

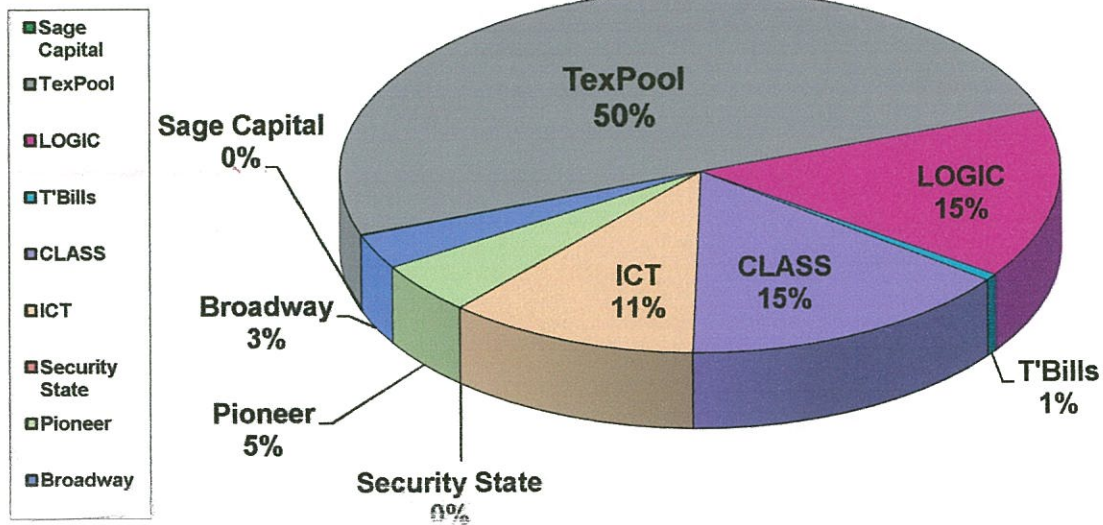
CURRENT 90 DAY TREASURY BILL YIELDING .076%
