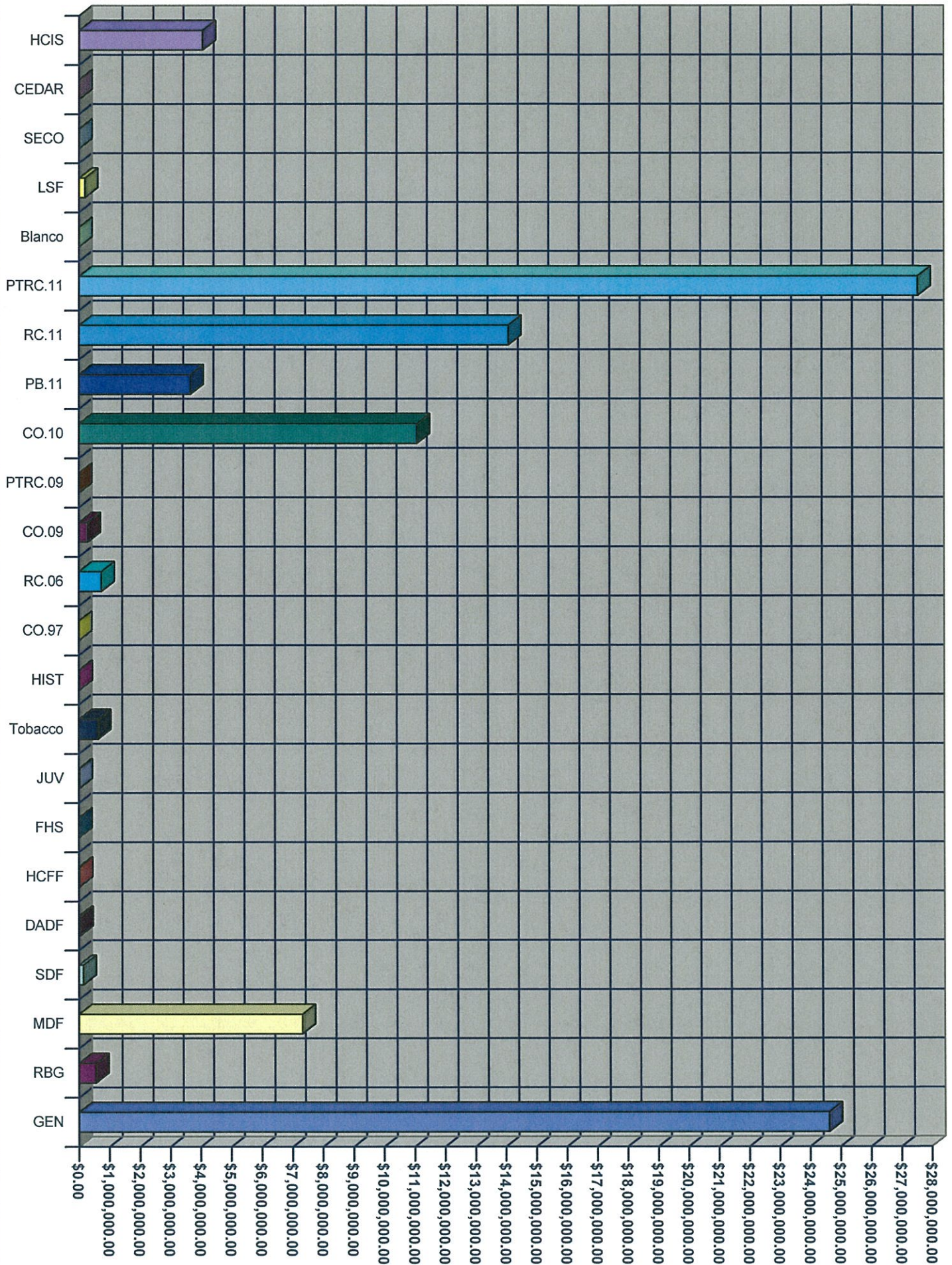

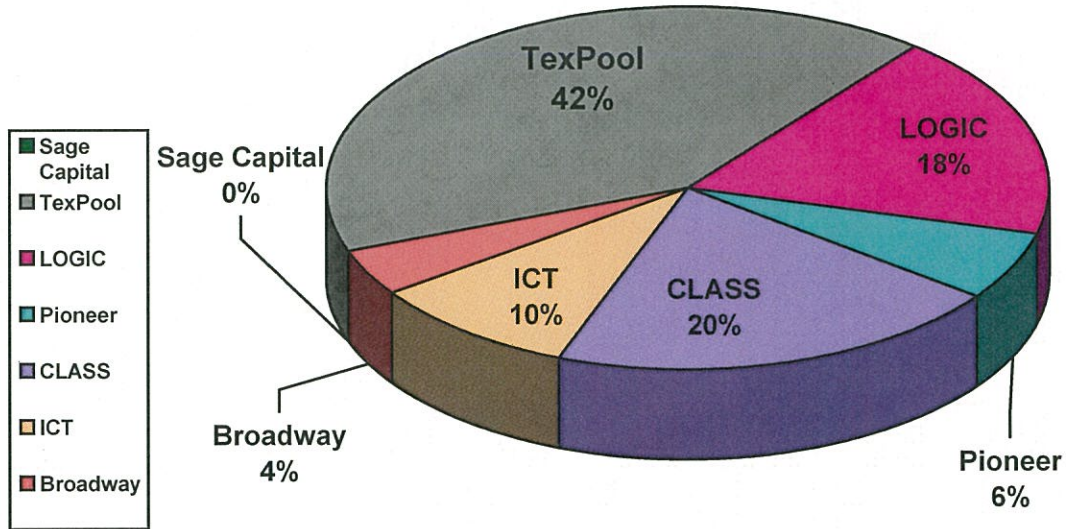


### Fund balances for 11/30/13
