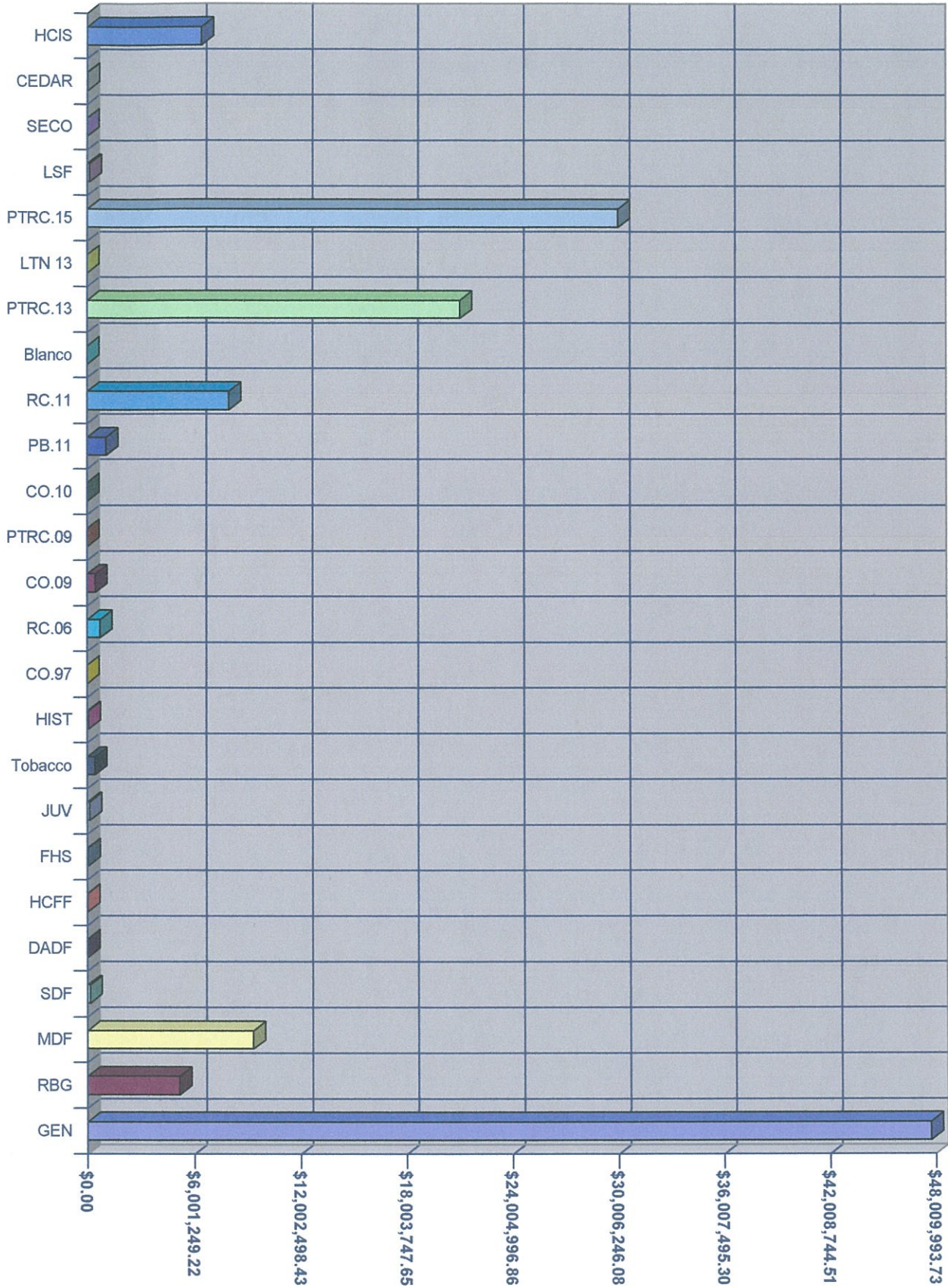

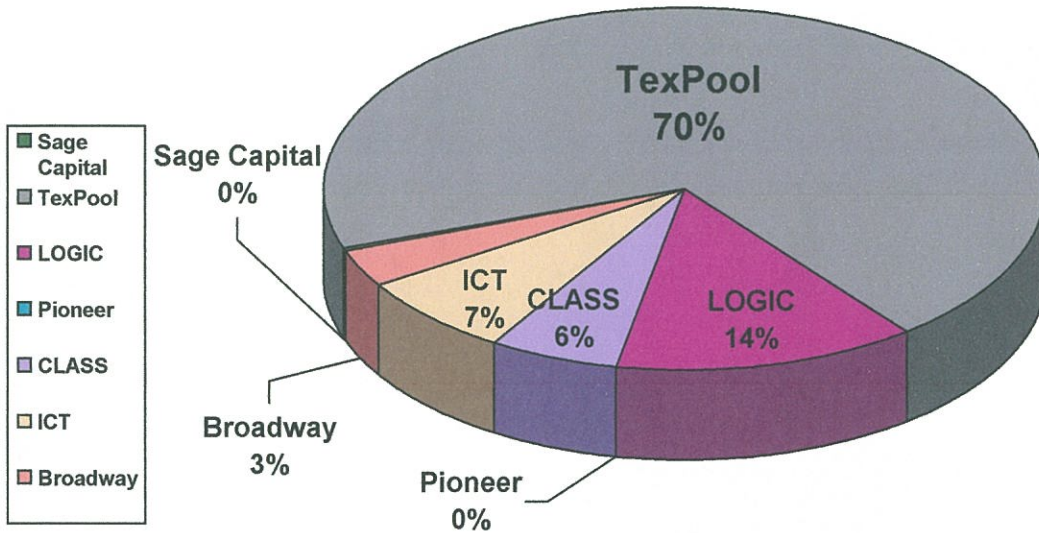


### Fund balances for 8/31/15
