- Build projects now
- Develop projects for future funding opportunities
  - Initiate schematic/environmental approvals
  - Acquire right-of-way
- Position to leverage other funding
  - TxDOT
  - CAMPO
  - Federal







- Future PTF Program
  - Potential call for projects Mid 2013
  - New program highlights include
    - Funding limited to 65% of construction cost only
    - Yearly reimbursement
    - New provisions limit the liability of parties in the event of construction overruns and underruns







- Identify potential pass-through finance projects
  - □ FM 110
  - □ FM 2001
  - Initiate environmental studies/ROW acquisition





- Transportation Reinvestment Zones (TRZ's)
  - Created by municipality or county for a contiguous geographic area
  - Intent is to generate funding for a project that is derived from the economic growth resulting from the project
  - Municipality or county must first determine the area to be unproductive and underdeveloped
  - Municipality or county authorized to contract with public or private entity to develop, redevelop or improve a project within a TRZ





- Transportation Reinvestment Zones (TRZ's)
  - Allows municipality or county to dedicate a portion of future tax revenues to the project through use of tax increment financing
  - Similar to TIF financing, but simpler administration
  - TRZ boundaries can be amended because of project scope changes, providing no property for which any portion of the tax increment has already been assigned pledged for bonds or other obligations is removed





- Future bond programs
- Participation by local governments
- Public-Private Partnership agreements with developers
- Develop projects to partner with TxDOT/CAMPO, such as:
  - FM 150 (Lehman Road to SH 21)
  - FM 967 (FM 1626 to Cole Springs Road)
  - Truck Bypass Road
  - Others
