


project map

RM 12 Parkway Project From RM 32 to SH 80 a length of approximately 7 miles







purpose & need for improvements PURPOSE (what are we trying to do?) increase mobility and safety in the corridor

NEED (why are improvements needed?) - increases in traffic volumes - population growth - vehicle collisions







where we've been; where we're going

- 2004-2007: Environmental studies for original RM 12 Project
- **2007:** Original RM 12 Project received a Finding of No Significant Impact (FONSI) from the Federal Highway Administration (FHWA)
- 2008: Hays County Road Bond passed
- **2008-2009:** Project development and Context Sensitive Solutions process
- 2009-2013: Design changes and FONSI re-evaluation process begins
- **2010-2012:** Phases of the project constructed, including the Safety Improvements Projects
- **December 2013: OPEN HOUSE**
- Late 2013/Early 2014: Hays County TxDOT and FHWA consider public comments
- Early 2014: Anticipated confirmation from FHWA that the FONSI is still valid Late 2014: Finalize right-of-way acquisition

PROPOSED DESIGN MODIFICATIONS INCLUDE: parkway section with wide median (where feasible) shared-use path facility for pedestrians and cyclists for the length of the project











Typical would occur between Oakwood Loop/ Saddle Mountain Dr. and Pioneer Trail



> Typical would run from RM 32 to Oakwood Loop/ Saddle Mountain Dr. and from Pioneer Trail to SH 80




next steps

- to preserve the corridor
- the anticipated environmental clearance would allow Hays County to purchase the additional right-of-way for the proposed parkway
- plans to construct the project, including the parkway section and shared-use path, may not occur for several

years

• if approved, the RM 12 Parkway Project will be constructed once funding is identified and population growth warrants the additional travel lanes
