#### Cancellation Clause:

Both parties agree that either party may terminate this agreement upon (30) days written notice to the other party. The contract price (annual dollar amount) will be pro-rated at termination based on the number of maintenance trips (out of a total of trips) that have been completed during the annual period as reflected in the Service Schedule.

#### Insurance Coverage:

The provider of services will maintain full insurance coverage, including Workman's Compensation and General Liability.

Note:

All other unforseen services not covered in the landscaping requirements will be considered as additional services with remittance arranged at that time.

This proposal does not cover the replacement of any growth damaged as a result of any situation occurring through circumstances beyond our control, or planting of any new growth.

#### Billina:

All payments on said contract shall be due to the provider of services by the 10th of the month following completion of the service.

All of the above services will be included at the contracted price. Grounds will be inspected to ensure proper maintenance and satisfaction of owner/manager.
