Roxie McGinnis, Development Services Manager spoke. The Resubdivision of a Portion of Jacob's Well Acres is a 304 lot residential subdivision located off of Mt. Sharp Road in precinct 3. The subdivision was platted in 1959 but was never developed. The proposed cancellation will convert 128 of those lots (Lots 5-36, Block A; Lots 5-36, Block B; Lots 5-36, Block C; and Lots 5-36, Block D) back to acreage. The established fee for plat revisions and cancellations is \$200 plus an additional \$50 per lot. Following that schedule, the fee for this cancellation totals \$6,600. Given that the fee greatly exceeds the cost required to process this cancellation, the applicant has requested that the fee assessed be based on actual staff time. The actual cost totals \$463.33. A motion was made by Commissioner Conley, seconded by Commissioner Whisenant to cancel a portion of the Resubdivision of a Portion of Jacobs Well Acres and vary from the established fee schedule; hold a public hearing. Roxie McInnis, Development Services Manager spoke. The Resubdivision of a Portion of Jacob's Well Acres was platted in 1959 but was never developed. Owners J.D. and Toni Vance purchased Lots 5-36, Block A; Lots 5-36, Block B; Lots 5-36, Block C; and Lots 5-36, Block D (totaling 71.21 acres) in March of 2000. Since that time, they have paid taxes on 80.14 acres which includes 7.99 acres of abutting undeveloped right of way (Debra Drive, Elm Street, Marcee Street, and North Road). The abandonment will relinquish the 7.99 acres of right of way to J.D. and Toni Vance and the quit claim deed will give them a clear title. A motion was made by Commissioner Conley, seconded by Commissioner Whisenant to abandon Debra Drive, Elm Street, Marcee Street, and North Road, located within a portion of the Resubdivision of a Portion of Jacob's Well Acres; authorize the County Judge to execute a Quit Claim deed that clarifies title after abandonment. All present voting "Aye". MOTION PASSED

AUTHORIZE INSTITUTIONAL OSSF PERMIT AND GRANT A VARIANCE TO SECTION 10-M(B) OF THE HAYS COUNTY RULES FOR ON-SITE SEWAGE FACILITIES AT 4620 WEST HWY 290, DRIPPING SPRINGS, TX

Roxie McInnis, Development Services Manager spoke. PGM of TX LLC is proposing a replacement OSSF to serve an expansion for a recycling business at 4620 West Hwy 290 in Precinct 4. This property is Lot 3a in the Ladera Subdivision (2.84 acres). Water will be supplied by private well. This ON-SITE SEWAGE FACILITY consists of a standard treatment system in which the effluent will be pumped to a low pressure dosed dispersal field. The system is designed for a maximum of 375 gpd. The system designer, Derrick Lormand, R.S. is requesting a variance to Section 10-M(B) of the Hays County rules for on-site sewage facilities which requires flow equalization prior to the treatment tank. His justification for variance: This business establishment is open five days per week and there are not surge loads anticipated during normal business operations. I have oversized the septic tank volume, by 20%, to account for the flow equalization requirement. The larger tanks by definition allow for increased retention time and consequently act as a baffle to help negate surge loading. The designer respectfully requests a variance from the Hays County Rules to allow for this mechanism to act as the flow equalization. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to authorize Institutional OSSF Permit and grant a variance to Section 10-M(B) of the Hays County Rules for On-Site Sewage Facilities at 4620 West Hwy 290, Dripping Springs, TX. All present voting "Aye". MOTION PASSED

28935 CHANGE DAYS OF OPERATION AT THE HAYS COUNTY TRANSFER AND CITIZENS COLLECTION STATIONS

Clint Garza, Director of Development and Community Services spoke. Under the Natural Resources division of Development and Community services Hays County operates the Citizens Collection Station (Driftwood) and the Transfer Station (Wimberley). Current days of operation are Monday, Tuesday, Thursday, Friday, and Saturday. After a departmental reorganization, staff placed comment cards at each location and where citizens were given the opportunity rate our performance and were also asked for their opinion on the general operation of the stations. Staff specifically asked the users for feedback on changing the days of the week that the stations are closed from Sunday/Wednesday to Sunday/Monday. The results of the survey were very positive overall, with much more feedback than expected. 61.2% of the respondents were in favor of closing on consecutive days, 7.3% were not in favor, and 31.5% were indifferent. A motion was made by Commissioner Whisenant, seconded by Commissioner Conley to change days of operation at the Hays County Transfer and Citizens Collection Stations starting the first week of May. All present voting "Aye". MOTION PASSED
