Theo E. Krenek, Jr. was born in Houston, Texas and grew up initially in Fayetteville, Texas. Later his parents moved to Paige, Texas, where he attended Bastrop High School. After graduating from Bastrop High School, Theo moved to Austin to attend the University of Texas, studying electrical engineering and computer science.

After college, Theo was employed in the high-tech industry in the Austin area for twenty five years with companies such as LCRA, UniSQL, CompuAdd, Pencomm Systems, IBM and Vignette. As the director of engineering for Vignette, his expertise was essential in helping grow the company from a small startup into a publicly-traded company. In 2007, Theo left the high-tech industry to focus on home building in the hill country area. His company, TEK Construction, Inc., focuses on building homes which are highly energy efficient using sustainable building practices.

Theo and his family moved to Driftwood, Texas in 2002, where he currently has four children attending school in the Dripping Springs independent school district and his oldest daughter attending the University of Texas at Austin. His wife of 23 years, Jacque Krenek, is a real estate broker in the hill country area. His children are actively involved in 4-H and FFA in Hays county, showing livestock and crafts in the county show for the past three years. Theo currently serves as president of the Dripping Springs Lions Club and is involved in volunteer work for local activities, and the Dripping Springs United Methodist Church.

Theo and his family looked at many areas outside of Austin when they choose to relocate in 2002. The Dripping Springs area was their top pick. It offered a great school system, a rural lifestyle and the opportunity to contribute to a community and have a sense of larger purpose. His only regret is that he didn't move here twenty years earlier.
