28975 ACCEPT A DONATION OF \$500.00 TO HAYS COUNTY SHERIFF'S OFFICE COMMUNITY OUTREACH PROGRAM FOR NATIONAL NIGHT OUT 2013 AND AMEND THE BUDGET ACCORDINGLY

The Sheriff's Office Community Outreach Program received a donation of \$500.00 from Mid-States Services and request to deposit into 052-618-00.5222. The donation will benefit National Night Out 2013. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to accept a donation of \$500.00 to Hays County Sheriff's Office Community Outreach Program for National Night Out 2013 and amend the budget accordingly. 28976 AUTHORIZE THE COUNTY JUDGE TO SUBMIT A GRANT APPLICATION TO THE U.S. DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE ASSISTANCE FOR FY2013 FUNDING UNDER THE STATE CRIMINAL ALIEN ASSISTANCE PROGRAM (SCAAP)

This is a grant that the County has been receiving for a number of years to recover some Jail operations expenses associated with incarceration of undocumented criminal aliens. The FY2012 amount received was \$64,768.00 and the FY2013 award will be determined based on the inmate data submitted with the application. The application is submitted electronically and is due on or before May 13, 2013. Justice Benefits, Inc. has been retained by the County to compile inmate records and other materials for submission with the application and will be transmitting this information shortly. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize the County Judge to submit a grant application to the U.S. Department of Justice, Bureau of Justice Assistance for FY2013 funding under the State Criminal Alien Assistance Program (SCAAP). All voting "Aye". MOTION PASSED

AUTHORIZE THE COUNTY JUDGE TO SUBMIT A GRANT APPLICATION TO THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES (DSHS), PUBLIC HEALTH EMERGENCY PREPAREDNESS (PHEP) PROGRAM IN THE AMOUNT OF \$121.300.00

The Grant Application is to the Texas Department of State Health Services, Public Health Emergency Preparedness (PHEP) program for funding to support the salary and benefits of the Emergency Preparedness Coordinator and SNS Coordinator in the Hays County Local Health Department. This grant requires a 10% match, with the match met through in-kind contributions from the Health Department operating funds. Upon award, the term for this grant will be September 1, 2013 through August 31, 2014. The amount available in the FY2014 grant is set by the DSHS and reflects a decrease of \$11,332 from the FY2013 award. The application is

due by May 2, 2013. Amount required \$12,130.00 (Most of this grant relates to the FY14 Budget and the match will be budgeted at that time). A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to authorize the County Judge to submit a Grant Application to the Texas Department of State Health Services (DSHS), Public Health Emergency Preparedness (PHEP) program in the amount of \$121,300.00. All voting "Aye". MOTION PASSED

28978 MOVE FUNDS FROM COUNTY WIDE CONTINGENCIES TO VARIOUS DEPARTMENTS FOR THE XEROX POOLED PRINTER PLAN PROGRAM

In September 2012, Hays County implemented a program for County printers through Xerox Corporation. Departments with participating printers pay a \$5 flat rate fee per printer plus charges for black & white or color prints to that machine. These fees cover all print cartridge and maintenance costs associated with the printer. It is anticipated that this program will decrease the amount of funds spent individually by departments on supplies and maintenance for printers. As this program was being rolled out during the adopted budget process, funds were not identified or budgeted during the FY13 budget process. It is anticipated that office supply line items can be reduced during the FY 2014 budget process to offset these program costs. Amount required is \$24,000; 5412-Budget. A motion was made by Commissioner Whisenant, seconded by Commissioner Jones to move funds from County Wide Contingencies to various departments for the Xerox Pooled Printer Plan program. All voting "Aye". MOTION PASSED

28979 AMEND INFORMATION TECHNOLOGY AND RECORDS ARCHIVE BUDGETS FOR EXPENSES RELATED TO THE GRANICUS SYSTEM

A new Commissioner's Court video system was approved during the FY13 budget process. Funds need to be moved into the appropriate g/l account to capture these expenses. No additional funds are needed. Roxie McInnis Development Services Manager spoke and gave staff recommendation. The proposed amended plat of lots 4 and 5, The Preserve at La Ventana, Phase Two, will combine the two lots into one 3.388 acre lot. The new lot will be served by an on-site sewage facility and La Ventana Water Company connection at the time of development. A motion was made by Commissioner Whisenant, seconded by Commissioner Conley to approve final Amended Plat of Lots 4 and 5, The Preserve at La Ventana, Phase Two. All voting "Aye". MOTION PASSED

In 2008, after construction of the home and fence on the west property line of Lot 7, the builder submitted a replat to the City of Drippings Springs. The minor lot revision was approved by the City but never went through the County process. The division will be served by existing connections to public water from a surface source and public wastewater. 28983 REPLACE EXISTING T1 DATA CIRCUITS WITH GRANDE COMMUNICATIONS FIBER CIRCUITS FOR THE FOLLOWING PRECINCT OFFICES; WIMBERLEY, KYLE, BUDA, DRIPPING SPRINGS

Jeff McGill Information Technology Director spoke. With the added requirements for technology in the Precinct offices, the Information Technology Department has determined that the bandwidth has become insufficient for adequate functionality of existing and future systems. The current monthly cost of existing 1.54M T1 circuits is \$2,825. The monthly cost to add 10MB fiber circuits would be \$3,975, which is an additional \$287.50 a month per Precinct. Project savings in overall telephone & data line expense line items will fund this increase. Amount required \$3,450.00 Precinct Telephone & Data Line Expenses #5489. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Whisenant to replace existing T1 data circuits with Grande Communications Fiber circuits for the following Precinct offices; Wimberley, Kyle, Buda, Dripping Springs in the amount of \$3,450 to be divided by those offices. AUTHORIZE THE COUNTY JUDGE TO EXECUTE A TRAFFIC ENFORCEMENT AGREEMENT BETWEEN THE HAYS COUNTY SHERIFF'S OFFICE AND THE RUBY RANCH SUBDIVISION

Sheriff Gary Cutler and Captain Mark Davenport spoke with the Hays County Sheriff's Office spoke. The Subdivision desires assistance from the Sheriff's Office in the area of traffic regulation in order to enhance public safety for its citizens. The Sheriff hereby agrees to provide law enforcement services within the Subdivision. The Sheriff's Office will not enforce Subdivision rules of ordinances unrelated to traffic regulation. The parties hereby acknowledge that the Sheriff's Office has limited resources and equipment with which to regulate state and laws within the Subdivision. The Sheriff agrees to patrol, investigate, file complaints, assist in prosecution, and do all things normally and customarily done in their normal law enforcement work. Traffic citations issued by the Sheriff shall be filed and adjudicated in the Precinct 4 Justice of the Peace Court and any fine collected shall be deposited with the County. A motion was made by Commissioner Jones, seconded by Commissioner Whisenant to authorize the County Judge to execute a Traffic Enforcement Agreement between the Hays County Sheriff's Office and the Ruby Ranch Subdivision. Roxie McInnis Development Services Manager and Clint Garza Director of Development and Community Services spoke. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Whisenant to authorize payment 2 for FY 2013 Intergovernmental Transfer (IGT) in the revised amount of \$850,000 to the State of Texas through the TexNet Electronic Payment System for Supplemental Payments to Central Texas Medical Center as part of the Texas Healthcare Transformation and Quality Improvement Program pursuant to 355.8201 of the Texas Administrative Code.
