On October 23, 2012 the Commissioners Court approved a Subaward Agreement with Texas State University for participation in the Advanced Law Enforcement Rapid Response Training (ALERRT) - VALOR program. On April 9, 2013 the Commissioners' Court approved the first amendment for this program, changing the training officer, extending the project completion date, and increasing the project budget. The current Amendment Number 13005-8-1812-1B-1966 will extend the project completion date to September 30, 2014 and increase funding by \$10,671.00, to a total project amount not to exceed \$24,070.00. On February 12, 2013, Hays County Commissioners' Court approved a resolution authorizing the County to formally request that TxDOT participate in the financing and construction of a proposed Partnership program of nine (9) projects. The County has since made the formal request to TxDOT and coordinated with TxDOT Administration and Austin District staff and Texas Transportation Commission members regarding the proposed Partnership program. Based on anticipated action by the Transportation Commission to formalize the Partnership program at their May 30, 2013 meeting, the Court would submit a SIB loan application for the FM 110 project. At the May 15, 2013 Commissioners' Court meeting, Court authorized the County Judge to direct Hays County consultants to initiate project financing implementation strategies for the proposed Hays County-TxDOT Partnership. This action would specify that the Court authorizes the submission of a SIB loan application for the construction of the FM 110 project to be funded via the proposed County and City Transportation Reinvestment Zones (TRZ's). A motion was made by Commissioner Ingalsbe, seconded by Commissioner Conley to authorize the County Judge to submit a State infrastructure Bank (SIB) loan application to the Texas Department of Transportation (TxDOT) for the construction of the FM 110 project (IH 35 at Yarrington Road to SH 123) and to adopt Resolution that is attached. All voting "Aye". MOTION PASSED

Judge Cobb opened public hearing. No public input. Judge Cobb closed public hearing. Roxie McInnis Development Services Manager and Commissioner Whisenant spoke. Willie Wii with Native partner with Werth spoke. The Werth Subdivision is a seven lot subdivision located off of Mirela Ann Road in Precinct 4. The owner of Lot 3E has proposed to divide the 23.8 acres into 13 residential lots and 1 open space/greenbelt lot. The residential lots range in size from 1.00 to 1.38, each of which will be served by an individual rainwater collection system and advanced on-site sewage facility. Section 721.4.02 of the Hays County Development Regulations establishes criteria for determining private roadway status. This section states that only developments which have an average lot size of five or more acres or for which the Commissioners Court has entered into a development agreement for a master-planned community of 50 or more lots shall be permitted to utilize private roadways. The developer is requesting that the proposed roadway be privately maintained, however, the average size of the 14 lots equals only 1.64 acres. A motion was made by Commissioner Whisenant, seconded by Commissioner Conley to approve a Grant in Variance to Section 721.4.02 of the Hays County Development Regulations for the Replat of Lot 3E, of the Replat of Lot 2 & Lot 3, Werth Subdivision predicated on the fact that it will be required a rain water collection and Advance Waste Water Disposal and predicated on full development of 50 plus Lots. All voting "Aye". MOTION PASSED An amended motion was made by Commissioner Whisenant, seconded by Commissioner Conley to Conley to approve a Variance to Section 721.4.02 of the Hays County Development Regulations and approve the Preliminary Plan Replat of Lot 3E, of the Replat of Lot 2 & Lot 3, Werth Subdivision and not to include a Phasing or Master Plan Submission at this time. On November 20, 2012 the Commissioners Court authorized the award of IFB #2012-B10 for Boundary Fencing for Jacob's Well Natural Area to Pecos Fence, Inc. The fencing project has been delayed due to demolition of existing buildings, and with the removal of these buildings it has become necessary to revise the fencing plan and increase quantities of both coyote and game fence, while reducing the quantity of stone columns necessary to complete the project. The Amendment accounts for the proposed changes, with a net increase in the Contract price of \$393.15 to an adjusted total Contract amount of \$27,449.15. A motion was made by Commissioner Conley, seconded by Commissioner Whisenant to authorize the County Judge to execute Amendment One (1) to the Contract with Pecos Fence, Inc. for boundary fencing at the Jacob's Well Natural Area. All voting "Aye". MOTION PASSED

29050 APPOINT TWO REPRESENTATIVES TO THE CO-LOCATED EMERGENCY COMMUNICATIONS CENTER EXECUTIVE BOARD

At the general assembly meeting on May 24, 2013 the group approved the creation of a 12 Member Executive Committee made up of 2 Representatives from each of the 6 Partner Agencies. The adopted organizational structure and proposed representation for the Co-Located Emergency Communications Center project. The task force felt that at least one elected official from each jurisdiction should sit on the board and either another Elected Official or member of staff should fill the remaining position. In this structure the Executive Board has all decision making authority regarding the development of this Center through the recommendations made by the Communications Taskforce comprised of Department Heads and Chiefs of the represented disciplines. A motion was made by Commissioner Conley, seconded by Commissioner Whisenant to appoint Commissioner Ingalsbe Pct. 1 and Commissioner Conley Pct. 3 to the Executive Committee of the Co-Located Emergency Communications Center Executive Board. ACTION TO FINALIZE CHANGES TO THE HAYS COUNTY DEVELOPMENT REGULATIONS; HOLD A PUBLIC MEETING AND APPROVE ORDER ADOPTING RULES FOR ON-SITE SEWAGE FACILITIES

Judge Cobb opened public hearing. No public input. Judge Cobb closed public hearing. Roxie McInnis Development Services Manager spoke. Upon implementation of the Hays County Rules for On-Site Sewage Facilities, it became evident that changes were needed in order to make the work of the Development Services Division more efficient and effective. The Texas Commission on Environmental Quality has approved amendments to these rules. Additionally, amendments to the Hays County Development Regulations are being proposed. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Conley to finalize changes to the Hays County Development Regulations as presented by staff. All voting "Aye". MOTION PASSED

AUTHORIZE THE COUNTY JUDGE TO EXECUTE A COOPERATIVE ENDEAVOR USE AGREEMENT WITH THE SOUTH CENTRAL PLANNING AND DEVELOPMENT COMMISSION FOR LICENSING OF SOFTWARE FOR USE IN THE DEVELOPMENT SERVICES DIVISION

Roxie McInnis Development Services Manager spoke. On April 29, 2013, the Development Services Division went live with the online database and permitting software, My Permit Now. This Cooperative Endeavor Use Agreement is with the South Central Planning and Development Commission (creators and licensors of My Permit Now) for asset management and GPS tracking / monitoring. This service will accomplish three goals: (1) Accountability to taxpayers - Through integration with the My Permit Now work order system, information regarding when, and for how long, county staff is present at a job site for an inspection or complaint will now be available (2) Statistical analysis of workflow - As development throughout the county increases, this service will allow Development Services to generate reports and make informed decisions regarding time management and staffing needs. (3)Transparency - This service will offer greater transparency into county operations. The collection of data will allow citizens to see that county assets are being used efficiently and effectively. A motion was made by Commissioner Whisenant, seconded by Commissioner Ingalsbe to authorize the County Judge to execute a Cooperative Endeavor Use Agreement with the South Central Planning and Development Commission for licensing of software for use in the Development Services Division. All voting "Aye". MOTION PASSED

AUTHORIZE THE COUNTY JUDGE TO EXECUTE AN INTERLOCAL AGREEMENT WITH THE GUADALUPE BLANCO RIVER AUTHORITY FOR HAYS COUNTY'S PARTICIPATION IN PHASE II OF THE FLOOD FEASIBILITY AND FLOOD PROTECTION STUDY

On November 3, 2009 the Commissioners Court approved a grant contract with the Texas Water Development Board (TWDB) to initiate a flood protection planning study on waterways in northern Hays County that is part of the Lower Colorado River Drainage Basin. On May 4, 2010 the Commissioners Court approved agreements with the Lower Colorado River Authority and the U.S Army Corps (USACE) of Engineers to partner in funding and conducting the study, with cost sharing of 50% by the USACE. On August 10, 2010 the Commissioners Court accepted a grant award amendment increasing funding from the Texas Water Development Board necessary to complete investigations of the drainage basin. Over the last two years, Hays County has worked with Halff Associates, the TWDB, and USACE to study the areas within the Lower-Colorado Drainage Basin including comprehensive studies of Onion Creek, Barton Creek and the Pedernales River drainage areas within Hays County, During this time the Guadalupe-Blanco River Authority (GBRA) initiated Phase I of a Flood Protection Planning Study in the Guadalupe-Blanco River Basin, including preliminary assessment of the Blanco River and San Marcos River. On August 16, 2011 the Commissioners Court approved an Interlocal Agreement with GBRA to participate in Phase I and allocated \$23,750 for detailed studies in the Woodcreek area and hydrologic modeling of the Blanco River. The proposed study will expand and provide a more detailed investigation of the above river basins and tributaries and incorporate a comprehensive inundation model for the 5 NRCS dams located on Sink and Purgatory Creek. On December 4, 2012 Commissioners Court approved a resolution in support of a GBRA's application to the TWDB for grant funding for the project. The GBRA grant application was approved and the study can move forward. Original estimates for the hays county match was \$131,170, split over FY 2014 and FY 2015. Since that time, the amount has been reduced to \$87,375 to be distributed equally in FY 2014 & FY2015. A motion was made by Commissioner Conley, seconded by Commissioner Ingalsbe to authorize the County Judge to execute an Interlocal Agreement with the Guadalupe Blanco River Authority for Hays County's participation in Phase II of the Flood Feasibility and Flood Protection Study. All voting "Aye". MOTION PASSED

29054 AUTHORIZE THE COUNTY JUDGE TO SUBMIT GRANT APPLICATIONS TO SOURCES THAT WOULD SUPPORT THE FUNDING FOR A HAYS VETERAN'S TREATMENT COURT PROGRAM

Jude Prather, Veterans Services Officer, Special Counsel Mark Kennedy and Jeff Hauff with Hays County Grants Administrator spoke. The court has discussed the possible creation of a Veteran's Court to help with the many issues that affect our Veterans once home. Travis and Bexar Counties have been very successful with their Veteran's Court and believe Hays County will have the same effect for our many Veterans. The authority for a Commissioners Court to create this program comes from the Health and Safety Code Title 7, Section 617.002. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Conley to authorize the County Judge to submit Grant Applications to Sources that would support the funding for a Hays Veteran's Treatment Court Program. All voting "Aye". MOTION PASSED
