**WHEREAS**, Connie Bagley is a Graduate of San Marcos High School, received her Bachelor of Science in Education from Southwest Texas State University and completed the Southern Methodist University Graduate Dyslexic Program; and,

**WHEREAS**, Connie became a teacher in 1972 and continues her 41 year career as a Dyslexia Specialist for students at Crockett Elementary. She has also taught second and third grade students, substituted in Florida & California, taught for the Department of Defense in Germany and tutored in Southeast Asia; and,

**WHEREAS**, Connie established a unique program through San Marcos Consolidate Independent School District for dyslexics which has become a best practice model for dyslexia programs worldwide. This program has been showcased through state, national, and international trainings & presentations; and,

**WHEREAS**, Connie has made a significant contribution to Hays County and its children by helping hundreds of children learn to read and, as a result, they have been able to meet with success in school and in life; and,

**WHEREAS**, it is Connie's preference to teach children with a learning difference, like dyslexia, how to read and to teach these children how bright and capable they are. She would like other teachers and the public to know how every child is a unique individual with special strengths and talents; and,

**WHEREAS**, Connie was awarded the Texas' Region 13 Teacher of the Year. The Texas Association of School Administrators is the State organization that selects the award recipients. She is the winner for Region 13 which in comprised of 60 public schools, 19 charter schools, 17 private schools, and 8 institutions of higher education across 17 counties in central Texas.
