The Sheriff's Office has utilized this vehicle as part of their SWAT Fleet; however it is currently in need of repairs and no longer a benefit to the SWAT operations. The City of San Marcos has expressed a need for the armored vehicle and has the resources to make the necessary repairs. Roxie McInnis, Development Services Manager spoke. Mark Smith dba 4660 SH 123 LTD is proposing to repair his OSSF to serve his building at 4660 SH 123 in Precinct 1. This property is 2 acres. Water is supplied by Public Water Supply. This OSSF is an existing aerobic treatment system in which the effluent is disinfected and spray irrigated. The existing pretreatment and aerobic treatment tanks have cracked and need replacement. This permit will authorize replacement of these tanks, the addition of an equalization tank and grant a variance for the system to utilize surface irrigation. The system designer, Andy Grubbs, R.S., P.G. is requesting a variance to Section 10-Q (7) of the Hays County rules for on-site sewage facilities, which does not allow surface irrigation for nonresidential use. His justification for the variance is: The fitness business averages less than 200 gallons per day, the system has worked well until construction workers drove over and damaged the tanks, a standard system will not be allowed due to the high clay soil, poor drainage, and seasonal groundwater within 18 inches of the surface. Equal protection to public health and safety will be achieved by using flow equalization to evenly dose the residential strength wastewater to the treatment system. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Jones to authorize Institutional OSSF Permit and grant a variance to Section 10-Q(7) of the Hays County Rules for On-Site Sewage Facilities at 4660 Hwy 123, San Marcos, TX. DISCUSSION OF ISSUES RELATED TO INMATE POPULATION AT THE HAYS COUNTY JAIL

Lt. Eric Batch of the Hays County Sheriff's Office spoke. Hays County's current maximum jail capacity is 362 inmates. Jail Standards recommends holding approximately 10% of capacity open. That lowers the jail recommendations to 311. The jail's daily average was 323 and peak was 328 for the week of July 21-27, 2013. The maximum female capacity is 56 inmates. Last week's average was 46 and peak was 49 on 07/25/2013. The maximum male capacity is 276 inmates. Last week's average was 276 and peak was 280 on July 26, 2013.
