THE STATE OF TEXAS COUNTY OF HAYS

On this 17th day of September, 2013, the Commissioners' Court of Hays County, Texas, pursuant to Chapter 26 of the Texas Property Tax Code, hereby adopts this order setting the fiscal year 2014 ad valorem tax rate as follows. All figures are in pennies per \$100 taxable property valuation:

General Maintenance & Operations General Debt	30.06 cents 12.46 cents
Road and Bridge Maintenance & Operations	4.38 cents
