BETWEEN HAYS COUNTY AND SCOTT YARBROUGH


This 2nd Amendment to the Professional Services Agreement ("Amendment") is made this ___ day of September, 2013, by and between Hays County, a political subdivision of the State of Texas (hereinafter referred to as "County"), and Scott H. Yarbrough (hereinafter referred to as "Contractor"). The above-cited parties are collectively referred to as "the parties to this Agreement" or "the parties."

4. Duration of the Agreement shall be amended to reflect that the Agreement will extend from July 1, 2013 to June 30, 2014.
