The Judge will provide a sample civil ceremony, or you may write your own vows. The Judge is agreeable to reading scripture. The Judge would like to have the final draft a few days prior to the wedding.

Please be on time. The Judge will arrive approximately 15 minutes prior to the ceremony to get final directives from you, receive paperwork and look over the premises. It's important that the ceremony start on time so that she can be on time to other commitments.
