HCLHD to relocate to new, larger building

The Hays County Local Health Department (HCLHD) is gearing up to provide more services to the rapidly growing Hays County community.

The expanded offerings include a larger space in a new building, located at 101 Thermon Drive in San Marcos. The expansion of the health department, both in terms of services and space, has been a priority for Health Department Director Tammy Crumley for quite a while.

She said the expanded services at the HCLHD will include childhood immunizations and adult safety net for uninsured, underinsured, and low-income residents as well as STI treatment. Crumley said the health department will celebrate the grand opening of the new location with a ribbon cutting at its annual Back-to-School Fair in the summer. She added that more details will be shared with the public in the coming months.

"I'm excited to see the positive change that this move will inspire within the health department and look forward to welcoming residents at our Back-To-School Fair," she said.

CHA Survey Results

The Hays County Local Health Department and Initium Health have concluded their public health survey as a part of the Community Health Assessment. The steering committee will utilize the results of the survey to develop the final portion of the community health assessment which is the development of a community health improvement plan. The community health improvement plan utilizes the results of the community health assessment to create a culturally inclusive and community driven plan to address the health needs residents expressed.

The following are the average scores for surveyed residents towards the questions below. 1 being very poor and 5 being very good.

Ratings also varied across different areas of Hays County. For example, the question "How would you rate the availability of public transportation?" had an average rating of 2.4 from San Marcos respondents, but only a 1.6 from Dripping Springs respondents. This shows that people living in different areas of the different county have public perceptions of health.

COVID CORNER

End of Public Health Emergency

The Public Health Emergency Declaration concerning COVID-19 is set to expire on May 11, 2023. This does not mean that the pandemic is over, rather that we are transitioning to a new phase. How will the end of the Public Health Emergency effect you?

COVID-19 Countermeasures

Depending on the COVID-19 countermeasure you are trying to access and your type of insurance coverage (Medicare, Medicaid, private, none, etc.) you may see little change, higher costs, or more limited coverage when it comes to accessing vaccines, tests, and treatments. See below for a brief overview of expected changes:

Vaccines

- Covid vaccines will remain free to everyone regardless of insurance status until the current federal stockpile runs out.
- Once the federal stockpile of vaccines runs out, the cost will depend on the type and level of insurance that an individual has. Most people will continue to pay nothing for the vaccines. Those with private insurance will need to use in-network providers. Those on Medicare and Medicaid will still be able to access vaccines at no cost. Uninsured and underinsured children will be able to access vaccines through the Vaccines for Children program (VFC). Uninsured adults may be able to access free vaccines through the Adult Safety Net (AFN) program but there may be a limited supply of vaccines.

COVID-19 Countermeasures

Treatments

- Antivirals and other treatments that were purchased with federal funds will remain free for everyone regardless of insurance status until the current stockpile runs out.
- Once the federal stockpile of antiviral treatments runs out, most treatments will be subject to cost sharing requirements regardless of insurance coverage type (private, Medicare, Medicaid). Those without insurance will have to pay the full cost of the medication plus any physician and office fees.

Tests

- Private insurers will no longer be required to cover the cost of at-home tests. Medicare and Medicaid plans will vary in their coverage of at-home tests.
- If a test is ordered by a physician and provided in a medical facility, it will be covered by insurance but may be subject to cost-sharing.
- Uninsured individuals will have to pay the full cost of testing and testingrelated services.


Another area that will be affected by the end of the Emergency Health Declaration is a change in the way that COVID-19 data is collected and reported. Laboratories will no longer be required to report negative test results. This will impact the ability to calculate test percent positivity. Hospitalization data will also change as some previously required metrics are being eliminated.

Expect to see changes to the county COVID dashboard as a result of this reduction in incoming data. Less comprehensive data will be collected from a variety of sources (rather than just medical facilities) and the focus will shift to monitoring COVID trends rather than capturing all cases.

EPI INSIGHTS

Childhood Vaccinations

The COVID-19 pandemic brought upheaval to many aspects of normal life. One area that saw an especially large disruption is **childhood vaccinations**. Many children fell behind on routine vaccinations due to delays in well-check visits, pandemic related barriers to care, and increasing misinformation surrounding vaccines. Hays County was not immune to these issues. Rates for routine vaccinations for kindergarteners in Hays County have **dropped by about four percentage points** over the past few years. (See chart).



Because of successful vaccination campaigns in the US over the past 50 years, most vaccine preventable diseases such as measles and polio are rarely seen here. Unfortunately, many of these diseases still circulate in other parts of the world and are only a plane ride away.

If enough people are unvaccinated, these diseases will have an opportunity to **reemerge and cause outbreaks** in the United States. Most parents understand the importance of routine childhood vaccination and make sure that their children are vaccinated. If your child has missed any of their recommended vaccines, schedule a visit with their healthcare provider so that they can "catch-up" on their vaccines **as soon as possible**. If you do not have a healthcare provider or do not have insurance, contact the Hays County Local Health Department for more information about how to find free and low-cost vaccines.
