Endangered Species Act Acknowledgement Form

I. Background:

Hays County is home to several species listed as threatened or endangered under the Federal Endangered Species Act, Title 16 of the U.S. Code (USC). 1531, et seq. (ESA). The U.S. Fish and Wildlife Service (USFWS) has determined that certain land uses may cause “take” of listed species, as that term is defined by the ESA and relevant regulations found in Title 50 of the Code of Federal Regulations (CFR) 17.3. Generally, take of listed species of wildlife is prohibited by the ESA, unless USFWS has issued authorization in the form of an Incident Take Permit (ITP) pursuant to ESA section 10 or a biological opinion and incidental take statement pursuant to ESA section 7. For a list of endangered and threatened species potentially present in Hays County, please visit USFWS’ website at <https://www.fws.gov/program/endangered-species>.

Hays County has received an ITP from USFWS that authorizes incidental take (take associated with otherwise lawful land use activities such as clearing trees for agriculture or development purposes of the golden-cheeked warbler and black-capped vireo (Covered Species) so long as the County implements the terms and conditions of the ITP. The County may allow individuals and entities to “participate” in the ITP and, thereby, receive incident take authorization through the County’s ITP.
